Sir,

I am commended by the Army Council to acknowledge the receipt of your letter ^{WO} 13720 of 23rd instant on the subject of the incidence of the cost of the employment of Political Officers with the forces operating against German East Africa, and to inform you that they agree that the ordinary salaries and allowances of these officers should continue to be borne by the Protectorate Government, any cost of replacement being borne by the ordinary account. They further agree that such allowances as in the opinion of the Governor should be granted to these officers in addition to the ordinary allowances of their civil appointments should also be charged to the common charges account.

It is understood that Mr. Secretary Bonar Law accepts the views expressed in the second paragraph of War Office letter of 21st ^{inst} as to the source from which the officers should draw all allowances, etc.

The Council would be glad to receive a copy of the instructions cabled to the Governor.
