Sir,

With reference to your letter No. 27994/1915 of the 29th of June, I have now the honour to transmit, for the use of the Colonial Office and the Government of the East Africa Protectorate, twelve copies of the Agreement recently executed with the East Africa Syndicate, Ltd.

2. Under clause 13 of the Agreement the Syndicate have paid to our Solicitors the net sum of £29. 2. 1., representing one-half of Messrs. Sutton, Ommanney, & Rendall's charges in connection with the preparation, etc. of the document, vizt £19. 13. 1., together with the sum of £19. 19. 0. due by the Syndicate in respect of the cost of telegrams, less the sum of £10. 10. 0. payable by the Government in respect of one-half of the charges of the Syndicate's solicitors in the matter. Messrs. Sutton, Ommanney, & Rendall in accordance with the practice in force have paid the amount over to us, and I have to enquire whether the Secretary of State approves of our now paying to them the sum of £39. 6. 2. in respect of their total charges in the matter as shown in the accompanying account.


