I had to be in the Privy Council this week in commention with connected Appeals in which I appeared on behelf of Mombasa Indians against the Kenya commissions for Lands, in which my nominal Client was Respondent in an Appeal by the Commissioner and Appellant in a cross-A, peal. The two points arising for dispussion and decision by the Judicial Committee were: (a) whether the Commissioner for Lands in giving notices of the sale of Leases of Crown Large in the residential area of Mombasa, by anotion, was entitled to restrict hids to Europeans only and to exclude Indians from bidding, and (b) whether he was entitled to insert in the wasses a special covenant restricting residence to suropeans only, and excluding Asiatics and Africans, save in the capacity of domestic servants. The first point was decided by the Appellate don't in East Africa in favour of the Indians and the second point against them. I did not discuss this case with you as it was sub sudice; but I happened to meet

MacGregor Ross in court, and he told me that he had mentioned the case to you in a recent talk that he had with you. It is of immense in ortance to the Indian community.

Sir,

I respectfully beg to bring to your notice the following facts with a view to having the interpretation of the wording of the White Paper of 1922 which covers the question of the waiver of restrictions as to residence of Asiatles in Township ireas in the Ociony and Protestorate of Kanya definitely settled.

I entered into negotiations for purchase by my firm (of which I am senior partner) of a house and plot ut Mombres held under a direct lease from the Crown dated 4th April, 1913, a sopy of which I attach hereto.

I would draw your attention to the covenant on the part of the Lesses restricting residence to Europeans and would also draw your attention to Notice of Auction of plant of May 20th, 1912, contained in the Kenya Official Gazette of let June, 1912, and more particularly to conditions "7" and "8" in the said notice which are in the following terms:

- 7. These plots shall be occupied by persons of European origin only and their domestic servents.
- 8. A number of plots will be surveyed on the North side of the read which runs at the back of the plots now advertised for sale. On completion of survey these plots will be sold by anotion and a notice will be published in the "Official Carette" giving conditions under which these plots may be leased.

I enclose also herewith correspondence with His Excellency the Governor of Kenya Colony, The Colonial Secretary and the Commissioner of Lands which explains the position.

5 In 1913, a distinguished similation expert, Professor thow Sci-William Simpson, furnished a report on sanitary matters in Kenya in which he advocated strongly a system of racial eggregation, both in the residential and in the commercial areas of the large towns. His news were accepted, and when the time came for applying them after

the war, this question of segregation formed one of the main points at issue between the European and the Indian communities.

6. At the end of the war it was decided to give effect to the long-standin desire of the European community for representation on the Legislative Council by means of elected members. The grant of elective institutions was approved by Viscount Milner in 1919 and took effect at the beginning of 1920. The number of European elected unofficial members of the Council was fixed at eleven, but provision was made for maintaining an official majority in the Council.

7 In 1918, the report of a local Economic Commission of Enquiry into post-war development was published. This contained disparaging references to the Indians then in Kenya, and advocated strict control of future immigration from India. Although the passages in question were repudiated by Lord-Milner as not representing the view either of His Majesty's Government or himself, the report undoubtedly added to the feeling of hitterness among the Indians.

R At the same tinge Indian sentiment, both in India and Kenya, was becoming more and more articulate, and a large number of claims was put forward by the Indian community in Kenya, including a demand for representation on the Legislative Council on an equality with Europeans. After full consideration and discussion, Lord Milner addressed a despatch on the 21st May, 1920, to the Governor of Kenya, conveying decisions on the various points at issue. That despatch has already been published locally in the "Official Gazette." The decisions may be summarised as follows:

(4) Arrangements to be made for the election of two Indian members of the Legislative Council on a special franchise.

(b) Arrangements to be made for elective representation of Indians on Municipal Councils

(c) No restriction on Indian immigration which would place the natures of India at a disadvantage as compared with other immigrants.

(c) No restriction on Indian immigration which would place the natives of India at a disadvantage as compared with other

It has been suggested that it might be possible for Kenya to advance in the near future on the lines of responsible self-government, subject to the reservation of native affairs. There are, however, in the opinion of His Majestv's Government, objections to the adoption in Kenya at this stage of such an arrangement, whether it take the form of removing all matters affecting Africans from consideration in the Council, or the appointment of the Governor as High Commissioner or Native Affairs, or provision for a special veto by the Crown on local legislation which touches native interests; and they are convinced that the existing system of government is in present circumstances best calculated to achieve the aims which they have in view, namely, the unfettered exercise of their trusteeship for the native-races and the satisfaction of the legitimate aspirations of other communities resident in the Colony.

His Majesty's Government cannot but regard the grant of responsible self-government agant of the question within any period of time which need now be taken into consideration. Nor, indeed, would they contemplate yet the possibility of substituting an unofficial majority in the Council for the Government official majority. Hasty action is so be strongly deprecated, and it will be necessary to see how matters develop especially in regard to African, representation, before proposals for so fundamental a change in the Copatitution of the Colony can to constrained. Meanwhile, the administration of the Colony will follow the British traditions and principles which have been successful in other Colonies, and progress towards self-government must be left to joke the lines which the passage of time and the growth for operation was indicate as being best for the country.
