Sir,

On the recommendation of this Committee George Paterson, Maxwell Road, Pollockshields, Glasgow, Conductor No. 1661, East London Mounted Rifles, who enlisted on 10th August, 1914, and was discharged on 24th December, 1918, is presently receiving treatment for tuberculosis in Knightswood Hospital here.

I have been in communication with the Scottish Board of Health relative to the case and have now a communication from them stating that under Army Council Instruction No. 1419 of 1918, where application was made for treatment on A.F. O. 1835a, in respect of man of the South African Contingent, the cost of treatment was borne by the Union Government, reimbursement being made by the High Commissioner. I may say that a certificate has been granted by the Medical Officer of Health of this Burgh certifying that the Tuberculosis from which Paterson suffers is not suitable to Service with the Forces. The Board of Health suggest I should ascertain from you whether the cost of the present treatment will be met by your Government and I presume in the circumstances I'll agree to this. Kindly advise me accordingly.

With reference to your letter of the 16th September regarding Mr. George Paterson, of 16, Maxwell Road, Pollokshields, Glasgow, I am directed to state that enquiry has been made and, as the records in London show, Mr. Paterson was not a member of any South African Unit serving in East Africa. There is a strong presumption that Mr. Paterson served in a unit raised in East Africa for service in East Africa, and if this is the case the matter would fall to be dealt with by the Consular Office. It is suggested that you communicate with the Under-Secretary of State for the Colonies, Downing Street, S.W. 1.
