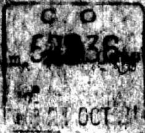

21st October your telegram 31st August suggests would be preferable to enact for one year Ordinance similar in terms to Ordinance No. 12 1917 with restriction as regards former enemy aliens since legislation following aliens restriction would not prevent former enemy aliens landing and stay less than 6 years by entering into agreement to acquire land for conveyance to them after expiration of ordinance viz for one year. Former Ordinance to be more applicable to local conditions.
