My Lord Duke,

I have the honour to refer to my telegram No. 230 of August 15th in which I informed Your Grace that three Cadets would be required in September and two more in October. I have since discovered that two Cadets are all that are required in September while three will be required in October but as savings will be available to defray the expense of one Cadet arriving one month before his time I have not considered it necessary to vary my requirements by

Magistrates on Uasin Gishu Construction. That left a working strength of 119 on July 1st, or two in excess of establishment.

4. During July, Mr. C.E. Spencer was transferred to the Prisons Department with effect from the date of retirement of Mr. Donald and Mr. F.C. Gamble ^{was} seconded as a Resident Magistrate. In August, Messrs. F.W. Isaac and C.S. Hemsted are due to retire. In September, Mr. C.R.W. Lane, Lieutenant Colonel R.E. Salkeld and Lieutenant Commander Heathcote are due to retire and Mr. H.R. Tate in October. That would leave in December a working strength of 111 or six less than the establishment, the vacancies falling due, two in September, three in October and one in November.

5. On January 1st, 1924, certain changes in the administrative establishment are contemplated the effect of which is to reduce the total establishment to 114 composed as follows:-

In January, therefore, there will be five vacancies only and I have asked for the appointment of five Cadets only during the remainder of this year being prepared to carry on with one officer under establishment during November and December in view of the reduction in staff contemplated in January.

6. One further vacancy will arise in April 1924 on the

the retirement of Mr. F.G. Hamilton, but I have made no allusion to this as I have not yet been informed whether Mr. Plowman's period of secondment will be extended beyond that date. If Mr. Plowman returns to duty before April, the staff will be one supernumerary to establishment until the date of Mr. Hamilton's retirement.

Your Grace will observe that my estimate of requirements is based on the secondment throughout the period under review of two officers for duty as Railway Magistrates. With the programme of Railway construction which is at present before the Colony, it is, I think, safe to estimate that two officers will be seconded for Railway Labour Inspection and Magisterial work at least until the end of 1934.

I think that in the light of this calculation, Your Grace's proposal for the engagement of five Cadets, two of whom should leave as soon as possible. The actual strength of the Colony is at a low ebb owing to the number of officers absent on deferred leave.

With regard to the three officers mentioned in Your Grace's telegram of June 16th, the return of Mr. Löwder, would be welcome, while I have no objection to offer to the selection of Captain P.S. Mumford on a probationary basis provided that this gentleman has the intention of adopting Native Administration as his permanent profession. I would not, however, advise his re-engagement on any other understanding.

I regret that I must strongly oppose the suggestion to offer re-engagement to Mr. Le Ghens: he proved himself unsuitable for appointment as an Administrative Officer and his return to the Colony in such a capacity would be unfortunate.


