The estimate for the cost of the two cargo steamers
and tug and installation of oil fuel in the Lake
Victoria Steamers Service has given a good deal
of trouble. The first estimate was £33,000, and
a transfer of 20% Treas approval was given for the
purpose of £20,000 from balance in 1911-12 and from
provision of £13,000 as required in the Est for succeeding
years (a part of the £20,000 which should all be
repaid in 1911-12, to be provided subsequently in
the Est).

The first estimate was made up as follows

- Oil fuel £ 7000
- Cargo steamer £ 20000
- Steam tug £ 6000
- Total £ 33000

Only about £6000 (on oil fuel installation) was
spent in 1911-12 out of the £20000 sanctioned
from balance by Govt. (see para 7 of C.O. letter
to Govt. on CR/442/12) leaving £14000
to be provided on Est. for 1912-13.

The Govt. now shows that the total cost has been
£49,593 whereas £47,000 was
sanctioned in one lump sum on 442.
Excess £2,593.

Nearly half the excess is accounted for by the
2 1/2% Consulting Engineer's fees a charge
which was omitted from the original Est.
Other causes for the excess are increase
in freight charges, cost of drawings omitted
from the Est. and increase in Est. Commission.
The Govt. proposes that the excess cost £2,593
should be met from balance on the ground
that £20,000 was sanctioned from balance
in 1911-12 towards the cost of this work.
But the stipulation in 1911-12 was that a
part of the sum of £20,000 which should be
drawn from balance in 1911-12 (and as
the greater part of the sum was not spent)
should be provided for on the Est. in future
years: and I don't think that the Govt. has
good ground for his present proposal as far
as the original £20,000 is concerned.
The Treasury, whom we are no longer bound to
consult, would I think, have refused it.
If the whole expenditure for the work had

been originally charged to balance in 1911-12
and it had been impossible to spend all the
money till this year the £2,593 might
be treated as a lapse of account and not
from balance but as a ~~lapse of account~~

Sir,

With reference to your despatch No. 16 of 11th January 1912 in which sanction was given for the expenditure of £47,000 to meet the cost of the new Cargo Steamer "Usoga" and tug "Kavirondo" as well as for the installation of oil fuel in the Lake Steamers, I have the honour to inform you that the General Manager, Uganda Railway, has reported that expenditure amounting to £49,593 has been incurred and that the amount originally sanctioned has been exceeded by the sum of £2,593.

2. The accompanying Statements give the items of expenditure and show clearly that there is an excess as stated.

3. I called upon the General Manager to submit further information as to whether it was not possible to foresee that the estimate would be exceeded and from his reply I have elicited the following facts.

4. In the original estimate two items, viz: "2 1/2% Consulting Engineers fees" and the cost of the "Drawings" were entirely omitted as they were not anticipated. These charges amount to Rs. 12,176.

Further the heavy excess in sea freight and launching charges, due probably to the great increase in shipping rates, accounts for Rs.14,363. Other minor excesses such as freight on the Uganda Railway and Crown Agents commission have been shown but it is mainly on account of the home charges and freight by sea that the total excess has occurred.

5. The matter was reported by the General Manager in October last and I find on enquiry that it was known as early as July that the estimate would be exceeded. I think that it should have been the duty of the General Manager to have reported the necessity for this excess expenditure as soon as it was realised, particulars could have been furnished later if they were not available at the time.

6. In the circumstances I would ask sanction to meet the excess from surplus balances. My reason for doing so is that originally a sum of £20,000 was sanctioned from that source towards the purchase of the new steamer, vide your despatch No. 507 of 14th September 1911 and I think that it would be more proper to charge it as I have suggested than to any savings on the Railway Works Extraordinary Vote.
