Sir,

I am directed by Sir Percy Girouard to acknowledge the receipt of your letter of December 30th, containing copy of a letter of December 18th on the subject of the Malindi Concessions, and would direct your attention to Mr. Fiddes' letter of the 9th Sept. 1910 in which you are informed that the Secretary of State was unable to reconsider a decision conveyed to you in a letter of 26th August, announcing that the agreement of February 28th 1910 had become void.

Mr. Fiddes' next letter of the 9th September informed you that should you desire to enter into negotiations for another concession in place of that which had lapsed, application should be made direct to the local authorities in the East Africa Protectorate.

I am to inform you that the whole subject of the grants of tropical land for plantation work is now receiving attention, and that until the question of Coast land titles within the 10 mile strip on the coast of British East Africa is definitely settled by the Land courts, there is no intention of granting any further concessions. Under the circumstances, any interview with Sir Percy Girouard would appear to be useless.
