SIR,

I have seen Mr. Leach M.P., on the subject of a grant of land near Kilili. I told him that his request should be forwarded to the Secretary to the Administration at Nairobi, as it was necessary to enquire into any other claims to these lands before he could be given any reply. At the same time he was told that if the area applied for came within the 100 mile strip, nothing could at present be done until the location of land titles and native rights was cleared up.

The intention apparently is largely that of collecting wild rubber over the same area formerly granted to the Sakoki Concessionaires, which proved abortive.

I pointed out that under no circumstances could I recommend the granting of an exclusive right to collect wild rubber where natives had previously held or were holding rights. He contended that his notice was clear of the areas, &c., but I pointed out to him that this same argument had been frequently used in the Congo, with ~~the~~ results only too well-known. I asked him also to furnish for the Secretary to the Administration, proof of want to develop any 5,000 acres - which was the limit of area which it was my intention to recommend to the Secretary of
