It is too early to embark upon a criticism of Mr Kinchin's proposals, which are complicated and in some respects ^{severely} technical. But it looks as if the first two of his requirements would ruin the whole proposal. I imagine that there is no probability of his getting a monopoly for 25 years of the right to erect Grain Silos on the coast of the East African Protectorate, nor do I see how the Government can have anything to do with a guarantee that 20,000 tons of grain per annum will be delivered to the Silos at Mombasa.

As far as I can make out Mr Kinchin puts forward a proposal which leaves him no room of any kind but imposes most serious and undesirable obligations on the government.

We might in the first instance send this letter out to the Governor for his observations, but I think that we should not do so without making it clear to Sir P. Girouard that there is no prospect of the Secretary of State agreeing to





Dear Sir,

I now beg to submit proposals in connection with the erection of Grain Silos and Grain Stores in British East Africa, for submission to His Excellency the Governor, Sir Percy Girouard.

I desire to intimate that supporting me in this business are the wellknown builders of Grain Elevators, Messrs. Spencer & Co. Ltd., Mr. Thomas Wiles, M.P., Mr. James Campbell of Middlesbrough, and others.

The Government may therefore rest assure that the proposed Silos etc. will be of the latest type, well equipped for handling grain transferred from a temperate to a tropical climate, and that if my proposals are acceptable, the erection will be undertaken without undue delay.

An early reply to my proposals will be esteemed, to enable me to make the necessary preliminary arrangements for the visit of Experts in the Autumn of this year.

I ask for -

(1) A Concession for 25 years from date of issue, under which I would have the exclusive right to erect Grain Silo or Silos on the British East African Coast Line, with the right to levy for receiving and delivering in

Shall pay to the Government 100/-, dues up to 2 rupees per ton, freight 10,000 tons, 1 rupee 75 for grain delivered over and not exceeding 150,000 tons, and 1 rupee 50 over 150,000 tons and not exceeding 200,000 tons (cost of bags and packing extra as may be agreed, as also any charge by the Government for inspection and grading).

The first Silo to be erected at Kilindini, and to be capable of storing at one time not less than 200,000 bushels of grain, and to be so designed as to permit of extension.

Promising to undertake from the Government that within one year after the completion of the Silo at Kilindini to receive and deliver grain, 20,000 tons per annum, to be delivered to the Silo, and failing delivery of that quantity to the Silo, a rebate of 2 rupees per ton in Railway freights to be made to the Owners of the grain Silo on grain received by them at any of the stations on the Uganda Railway for transport to the Silo at Kilindini, until a sum equivalent to 2 rupees per ton on the tonnage short-delivered to the Silo in the preceding 12 months has been received. Grant by the Government of the necessary land at Kilindini for the site of Silo, and any additional land thereof, with Powerhouse if required; a Conveyance situated in close proximity to the Deep Water Pier erected by the Government, so as to permit of the conveyance of grain from the Silo by Conveyor or Conveyors to the Government Wharf. The right of passage for such Conveyor.

Conveyor or Conveyors to the Government Wharf, the right to construct on the Wharf the terminal or terminals of the Conveyor or Conveyors, in such a way as not to interfere with the passage of Railway trucks of normal dimensions on quay Railways.

(4) The right to ship grain free of quay dues on the grain, but vessels to pay such tonnage dues as may be levied on ships for the use of the port, the Government to undertake to charge on any grain not shipped through the Silo Shore dues at the rate of 2 rupees per ton, such dues if collected to be for account of the Owners of the Silo after deduction of guarantees required under clause 2.

(5) Preferential right to berth a steamer at the wharf to load from Grain Silo. This preferential right to run from the removal to another portion of the Wharf as soon as a vacancy permits, or the sailing of any steamer berthed opposite the Grain Silo and not to load grain.

Should there be a steamer loading grain from the elevators, and another or more steamers in port waiting to load grain, such steamer or steamers to follow in regular time at the grain berth, although their date of arrival in the port may be after that of steamers waiting to load or discharge general cargo, always provided that the grain is in the Silo for steamer berthed into berth, and that the steamer may not occupy the grain berth to load or discharge general cargo, except during the time occupied in loading grain, if other steamers are in the port waiting to load grain.

(6) In connection with the Grain Silo, electric.

power is required, and I am prepared to instal a plant to supply all power required by the Government for the Wharf and lighting at Kilindini, and to extend this plant from time to time, the Government undertaking to take their power from such station for a period of 25 years, at (to be arranged) per Board of Trade Unit, or the Government may undertake to provide power for the Silo from an electric power station to be erected by them at (to be arranged) per Board of Trade Unit.

(7) The right to erect at any Station or Stations on the Uganda Railway and its extensions, Stobes or Stores for the receipt of grain for transport to the Silo at Kilindini. Sites and Railway Sidings for such Stores to be granted rent free during the currency of the concession, as per clause 2. The charge for handling of grain in such stores is to be from time to time agreed with the Railway Commissioner.

(8) To receive an undertaking from the Uganda Railway, that Grain which may be proceeding for shipment to the Coast, but owing to temporary stoppage is delivered into an up-country Silo, and afterwards re-loaded and delivered to Kilindini, should be charged the ordinary rate from point of despatch to up-country Silo, but when ultimately delivered at Kilindini, the Railway Co. to accept a rate not exceeding the through rate to Kilindini.
