I have the honour to inform you that owing to the additional staff now working in the field the work in the Cadastral Branch of the Survey Department has increased so much of late that extra clerical assistance is very urgently needed. The Chief Clerk goes on leave this month and the remaining two clerks cannot cope with the correspondence and keep it up to date.

2. I would therefore ask sanction for the engagement of a European clerk on the usual salary of £130 by £110 to £200, unpensionable plus £40 House Allowance, and a Goanese of the 3rd grade at Rs. 125/- per mensem with no allowances.

3. Provision was unfortunately not made in the draft estimates for these appointments as such, but there will be no difficulty in meeting the necessary
