My Lord,

With reference to Your Lordship's despatch No. 221 of the 4th May 1906, I have the honour to submit extract from a Minute by His Majesty's Principal Judge in connection with next year's Estimates. The Treasurer concurs in the recommendations made by His Honour Judge Hamilton, but in view of the orders contained in Your Lordship's despatch above noted, I have some diffidence in again bringing forward a proposal to place the Magistrates on an incremental salary. There is, however, this to be said, that the salary of the Magistrate at Mombasa used to be £500 and that of the Magistrate at Nairobi, a special case, £600, and that all along the Principal Judge has pressed for a reconsideration of the present scale.

P E N A L T Y

PAY OF MAGISTRATES AND THIRD JUDGE.

Both these matters have been already raised; and on the question of the reduction of the pay of the Magistrates I have already expressed my views both here and at home, but, I regret to say, with a negative result. This reduction was made by the Colonial Office before my scheme for a proposed re-valuation of pay had been considered.

The scheme proposed by me was for Magistrates to be appointed at £400 with an annual increment of £25 commencing after the first year's service and continuing till the salary reached £500.

It is sufficient that an impartial consideration of this proposal both on its own merits and with reference to similar rates of pay of professional men obtaining in the Protectorate will appear reasonable. For example, a District Magistrate should not, I think, be less favourably treated than a Medical Officer. It is hard that a Magistrate with serious responsibilities should in addition be worried over the question of ways and means.

The third Judge has identical duties, powers and responsibilities to those of the second Judge but receives £100 a year less salary.

So long as the pay of the Principal Judge remains at £300 both his colleagues should, I think, be paid at the same

same rate as the second Judge now receives, viz: £,700.

This recommendation was made in last year's estimates but was not sanctioned, and I would ask that it may be approved in the forthcoming estimates.

I have the honor to acknowledge the receipt of your despatch No 399 of the 29th of Sept last relative to the salaries of magistrates in the E.A.P., and to invite your attention to my confidential despatch of the 22nd inst in connection with the salaries of magistrates and the rates of pay of certain classes of officers in the Post office.

You will observe that in the 15th para of that despatch I have mentioned a salary of
