Sir,

I have had the honour to receive your despatch No. 307 of July 19th regarding the appointment of Inspectors in the Police Department of this Protectorate, and I have noted your instructions with regard to future local appointments. I regret, however, to state that before the receipt of this despatch Sir D. Stewart had, as already reported, appointed Messrs. R. Anderson and C. S. Long-Innes.

2. I have the honour to transmit herewith a statement of the qualifications of the Inspectors appointed locally. With one exception, that of Mr. Tulloch, all the Inspectors have had either police or military training. Mr. Tulloch's principal qualification is a good knowledge of Swahili and Hindustani which is not possessed by most of the others.

I have no hesitation in saying that it would be preferable to have Inspectors of Police drafted from the Royal Irish Constabulary, but as great difficulty has hitherto existed in inducing good men to join on one hundred and fifty pounds or one hundred and eighty pounds a year, we have considered it advisable to fill the vacancies locally rather than wait.

4. As I have found it necessary to dismiss Mr. Seaton-Winton for drunkenness and other offences, there now remain three vacancies, and I should be grateful if they could be filled from home at an early date.

5. With reference to the last paragraph of your despatch No. 523 of July 28th, I have the honour to report that Inspectors of Police should be subject to the leave rules and regulations of the Subordinate Staff (copy of which is enclosed herewith for your information.) No agreement as to length of service is necessary, as paragraph 3 of the Indian Police Act, lays down that no Police officer may without special leave resign or retire from office.


