In reply to Your Lordship's Miscellaneous despatch of December 9th, transmitting the Audit Department Estimates for 1908-09, I have the honour to report that the total is £28 less than the Estimates drawn up locally in conjunction with the Assistant Comptroller and Auditor General.

1. The most important variations are:-

- (1) The omission of provision in the Estimates forwarded with Your Lordship's despatch under reply for two clerks at £100 each;
- (2) the omission of any provision for passage money for the Audit Staff, whereas £175 was inserted in the Estimates prepared locally;
- (3) the provision of £415 more than has been allowed locally for the share of Home Audit expenses.

Items 1 and 3 depend on whether it is decided that the Expenditure Accounts should be audited at home or locally. In this connection I would invite a reference to my despatch No. 446 of October 16th last.

2. The minor variations are:-

- (1) The Comptroller and Auditor General's estimate includes


(c) There is an excess of £53 in the locally prepared Estimates for the salaries of the five Assistant Auditors. The figures inserted by the Comptroller and Auditor General are probably the correct ones, the difference being due to Mr. Bradney's transfer to Uganda and consequent changes of Staff.
