Sir,

I have the honor to report with great regret the sudden death of Captain E. E. Farnall, R.N.R. on board the S.S. "Minifred" in Bukoba Harbour at 8 a.m. on Thursday the 19th March 1908.

He appeared to be quite well in the morning and took the ship from the outer anchorage to the Inner anchorage, anchoring at 6.45 a.m. He sent for me at 7.30 a.m. after having had his bath, and informed me he was dying. The words used being "I'm dying, I'm dying, My heart." these were the last words he spoke.

I administered a little brandy and then sent "Glad" ashore for the Doctor requesting him to come at once.

He died at 8 a.m. and when the Doctor came on board at 9 a.m. after examining him, passed verdict "dead". The Agent was informed at once and the funeral arrangements were taken in hand.

His body was landed in the Cutter towed by "Glad" at 3 p.m. with all available hands from ship. The Commandant with all European staff and escort met near the Government House and accompanied coffin to the European Cemetery. At the grave the Commandant said a few words after which three volleys were fired and the coffin lowered into the grave.
