We may have misinterpreted the Superannuation Agts; but our experience of their practical working is very small.

At the time of Mr.S.P.R.de Sense's being invalided out of the service he had completed seven years service.

His noture salary was Re.125 per member, i.e. £100 per annum, but the average salary drawn by him during the last 3 years of his service was Re.122-47 cents per member, i.e. £97.19.5 per annum.

We accordingly recommended to the Golenial Office that a gratuity of Rs.887-31 sents be allowed, being the equivalent of months salary for each year of certics at the average rate of salary drawn during the last 3 years of service. The Colonial Office, in referring the case of the recovery, suggested a gratuity of Rs. 1-21 community and the Lords Commissioners of the Treasury decided that no gratuity was allowable

The gist of Mr.de Sousa's communication to the Colonial Office is a protest against this decision.
