GEORGE RUSSELL HAYNES CHELL fully sworn states H.R.C.S. L.R.C.P. Medical Officer East Africa Protectorate in charge of Native Hospital Nairobi. Suliman was admitted to hespital on May 4th died on May 5th. I held a post mortem I made a report on the examination report made next morning. (Report not allowed). Death due to Septic Meningitis of brain caused by fractured rib penatrated lung and so caused an abcess about the seat of fracture. Sixth rib from top on left side, just under shoulder blade about one inch from attackment to spinal column. Not a fracture of old standing. I should say fracture had been made not more than three weeks before. No external marks to show how rib had been fractured - two wheals on left arm and on back. Not in the neighbourhood of rib.
