In reply to Your Lordship's despatch No.199 of the 14th ultimo and previous correspondence respecting the free transport to be allowed for officials when travelling by rail, I have the Honour to report that I have consulted the Acting Governor of the Uganda Protectorate and that he concurs with the proposed regulations, a copy of which is attached.

2. I would preface my remarks by observing that the Railway has as a matter of fact always received full back credit for all accommodation reserved for officials at the same rates as those charged to the general public. From paragraphs 2nd and 6th of Your Lordship's despatch No.449 of August 6th last I gather that some misunderstanding may have existed on this point.

3. Your Lordship will observe that in the draft now submitted certain supplementary concessions are suggested in addition to those sanctioned in Your Lordship's despatch No.408 of August 21st 1908.

4. In the first place it is proposed that the privilege of free transport by rail for his wife should

should be extended to every officer travelling on Government service including journeys on sick leave. At present it is only enjoyed by those who are entitled to a reserved compartment. The extension would be much appreciated.

6. Similarly it is felt that the definition of a 'household' as two servants only presses somewhat hardly on married officers whose menage would certainly include at least three. I trust therefore that the larger number may be sanctioned on appointments, leave and transfer, and in cases where journeys by rail and road are combined.

7. For such journeys the ordinary amount of baggage permitted when travelling officially would also be insufficient to allow of provisions, camp kit, &c. being included, and it is therefore recommended that free transport on the Railway be given for the number of loads authorized for officers on tour, viz: 18 for Provincial Commissioners and Heads of Departments, and 15 for junior members of the Staff.

8. By free transport is understood at the cost of the officer's department; the railway will receive full back credit as explained above.

9. Certain officers have European servants, nurses, or governesses. In such cases I think that a second class ticket should be allowed in lieu of one third class ticket for an African servant.

10. When officers' families precede or follow them in proceeding on or returning from leave I would propose that the same facilities be allowed as when they

they are accompanied by Officers themselves.

10. The foregoing suggestions relate primarily to European Officers drawing salaries of £250 per annum, or more, but I would apply them mutatis mutandis to other members of the Staff, with suitable reductions in the class of accommodation, the number of servants and the amount of baggage, as specified in the draft regulations.

11. The existence of ^a uniform system whereby all questions of this nature whatsoever class of Government servants they may concern, can be settled on definite principles will save a vast amount of clerical work and correspondence and I trust that Your Lordship will sanction the recommendations put forward.

1. The following will be entitled to a reserved Saloon:-

Their Excellencies the Governors of East Africa
and Uganda.

[His Honour the Lieutenant Governor, East Africa
Protectorate.]

Chief Secretary, Uganda Protectorate.

Inspector General, King's African Rifles.

2. All other officers will be entitled to the accommo-
dation and transport for themselves, their families and
households defined and specified in the attached schedule.

3. All officers are allowed free transport for their
families, by which is meant wife and children, on first
appointment, leave and transfer, and also when travelling
on local sick leave. [For the purpose of these regulations
the annual 14 days leave will be treated as sick leave in
the case of all officers stationed at the Coast or at the
Lake. In the case of other officers sick leave will only
be granted on the recommendation of a Medical Officer.]

4. The above specified amounts of luggage to which
officers are entitled are additional to the amounts carried
by the Railway free on each ticket. On no account is more
than 3 cwt. to be booked at "luggage rates", any excess
beyond that amount must be booked at Goods rates.

5. Officers are also allowed free transport of a horse
or mule when travelling on official duty provided that the
horse or mule is necessary for the performance of this duty.
[They are also allowed free transport for one horse or mule

from

from London or place of purchase within the Protectorate
 to their nearest Railway Station, and in cases when
 a private allowance has been approved by His Excellency for
 one private.
 A railway ticket will not rank as a "Salary" for
 the purpose of these regulations unless it provides at
 least one night in Camp.
 7. Officers leaving on leave or returning from
 the camp will be when color on leave or returning from
 their duties to the same accommodation as in
 accompanied them.
 8. Officers are entitled to be accompanied by their
 European servants, in lieu of one of the said class
 allowed.
 9. Special regulations apply in the case of
 members of Provincial Commissions or of
 Headquarters of the District, who shall have to pay
 for their accommodation the same as when an officer shall be
 held to perform.
