Re Water-Supply near Lake Magadi, E. Africa.

The only permanent water-supply near Lake Magadi is to be found in the Gussa Nyiro river which approaches within six miles of the South end of the lake.

This stream in December, during the season of small rains, was over 12 yards wide, 2 feet deep and had a swift current. Its volume at that time would have been amply sufficient for all domestic and technical purposes. As its source is in the forest-covered hills on the plateau west of the Rift Valley, its volume is probably fairly constant.

A pipe-line about 6 miles long, rising at its summit to about 300 feet above the river-level would be required. There appears to be a good supply of fuel suitable for a pumping-engine, along the river.

There is no permanent stream between Lake Magadi and Mia Station. The water-courses shown on the map are only ephemeral.

The 'Fresh Spring' marked on the map 3 miles East of the South end of the lake, is, as far as I could see, only a rock-reservoir, filled by occasional

rain-

rain-storms. It holds from 1,000 to 2,000 gallons or possibly more, but has no overflow.

The water of the Quaso Nyiro is perfectly fresh and only slightly turbid.




The Governor of the East Africa Protectorate to the Secretary of State for the Colonies.

(Received Colonial Office 5.32 p.m. 2nd June, 1910.)

No.90. if Masai move approved river in question will be wholly in reserve and as they are not agriculturists in water supply will be in this event secure. No precautions can be taken to day but law gives Government right over all water. If settlers remain on Uaso Nyiro they would consider it breach of faith and case for compensation if we say farms are not to be irrigated. Land at port. I have sent through you last mail reply to private enquiry Samuel on that point. From your telegram gather land is wanted at Kilindini; this is not in accordance with Samuel's private query which speaks of mainland for their depot; please advise which is correct. Matter lengthy for cabling, despatch explain(s) more fully.
