the conditions as to development imposed in respect of those areas; that of the new areas which you wish to acquire Farm 7 has been allotted and cannot be granted to you; that the other farms mentioned cannot be allotted to anyone till native rights have been settled and other applicants have been satisfied; that the Governor will, however, endeavour to meet your wishes by grants on the Juba, not necessarily the particular farms for which you apply; and that there must be delay in surveying as the Survey Staff is fully occupied elsewhere. The Governor adds that the matter had better be settled locally on the usual terms and that even his telegram is liable to mis-understanding.

3. In view of the complexity of the matter and the Governor's express wish
