My Lord,

With reference to the correspondence ending with Sir C. J. Lyall's letter No. J. and P. 1907, dated the 26th May 1909, we have the honour to forward a copy of a letter No. 563, dated the 2nd February 1910, and its enclosures from the Government of Bombay, relating to the irregular recruitment of certain Britains for service in British East Africa. The irregularity complained of is a direct contravention of Section 75 of the Indian Emigration Act, 1908 (XVII of 1908), and is punishable under Section 96 of the Act. We would therefore request that the matter may be brought to the notice of the authorities of the British East Africa Protectorate.
