My Lord,

I have the honour to acknowledge the receipt of Your Lordship's despatch No. 150 of March 14th respecting various matters of detail connected with the formation of the reconstituted Survey Department in the East African Protectorate.

2. With regard to paragraph 3, it is not the practice in this Protectorate to charge customs on goods imported for the public service: a declaration of the value of such goods is however required by the Customs Authorities for statistical purposes. Duty is likewise not levied on personal baggage, but it must be paid on the stores supplied by the Crown Agents and afterwards sold to the members of

to exempt such stores from duty in the case of one.

Department when no other Department enjoys a similar privilege.

3. - I have the honour to report, with reference to paragraph 7 of your Lordship's despatch under reply, that the private effects of all persons are exempt from duty when brought by the owner into the country. Government employes are allowed five hundredweight of luggage free when travelling in country on the Uganda Railway and three hundredweight when returning to the Coast. Anything in excess of this weight has to be paid for. The free transport of goods is restricted to certain classes and does not include liquor, groceries or ammunition. In addition to the five hundredweight of luggage allowed on the railway, officers receive fifteen loads per annum transported free to any station in the Protectorate.

4. The cost of the carriage of the Survey Stores on the Railway has already been charged against the Survey Vote as the Transport Department Vote of the Protectorate was not estimated to include the cost of the survey transport. I am of opinion that it will

be

be best to continue to charge these expenses against the Survey Vote, though I agree with the views expressed in your Lordship's despatch No. 147 of March 21st that it is desirable that as much money as possible should be available for actual surveying operations. If Colonel Smith finds as the financial year advances that further expenditure is unavoidable, he can submit a supplementary estimate, on which I shall be able to decide how the additional expenditure should be met.
