Sir,

In accordance with instructions, I have the honour to forward herewith all the unissued stock of medals for favour of transmission to the proper authority.

I herewith send a nominal roll of the soldiers for whom they were originally sent out.

The cause of having so small a number of medals unissued on hand is that these men were discharged from the service and their medals could not be sent out as their whereabouts was not known to this office, owing to the fact that at the time of their discharge it was not the custom to ascertain their probable place of residence.

I have not submitted any medals which have also returned, as we did not know the names of the men who were entitled to this, therefore medals without any names. 309 have been issued and 60 are herewith returned.


