DEANSHIP HANDOVER REPORT

A SUMMARY OF THE KEY MILESTONES ACCOMPLISHED DURING THE DEANSHIP OF PROF. KIARIE MWAURA BETWEEN DECEMBER 19, 2016 AND MAY 4, 2021

Background

Universities play a key role in shaping the future of society. Research has shown that there is a correlation between the quality of higher education and the social economic development of a country, especially its ability to compete in the global marketplace.¹ Apart from this, they fulfil other objectives of university education by: promoting learning in the student body and society; advancing knowledge through quality teaching and scholarly research; fostering capacity for independent critical thinking amongst students; training of professional and management personnel; disseminating to the general community the outcomes of research; supporting life-long learning; promoting gender balance and equality of opportunity for persons with disabilities, minorities and other marginalized groups; and enhancing the cultural and social life of society.²

Over the last fifty one years, the Faculty of Law (previously the School of Law) has been part of the Kenyan societal transformation and has trained more than 12,500 lawyers. Of these, 2412 graduated in the reporting period. Its alumni body continues to make significant contributions to society and has, indeed, produced the first female Chief Justice (Hon. Justice Martha Koome - Class of 1986) in the history of the country.

Kenya is experiencing a significant youth bulge which is expected to raise its current population of 55 million to 110 million by 2050.³ As the population

grows, more highly skilled lawyers will be needed to handle the increased demand for legal services in the expanded market economy. This is expected to enhance access to justice, a factor that is integral to the attainment of the UN Sustainable Development Goals (SDGs).

With the current number of 18, 500 advocates (12,003 in active practice), Kenya has one practising lawyer for every 4582 persons. Comparatively, the USA has one practising lawyer for every 244 persons, Australia has one practising lawyer for every 327 persons, the UK has one practising lawyer for every 408 persons, Singapore has one practising lawyer for every 896 persons, Malaysia has one practising lawyer for every 1937 persons, South Africa has one practising lawyer for every 2132 persons, and Nigeria has one practising lawyer for every 1802 persons. As such, the demand for legal education in Kenya is expected to rise with the population growth and economic development.

The Faculty offers three degree programmes, namely: Bachelor of Laws, Master of Laws and Doctor of Philosophy and it has a population of approximately 4000 students spread across its three campuses of Parklands, Mombasa, and Kisumu. It continues to attract foreign/international students from Uganda, Rwanda, Burundi, South Sudan, Somali, Ghana, Tanzania, Mozambique, Malawi, Zambia, Zimbabwe, Canada, and the UK. The Faculty was founded in the late 1960s as the Department of Commercial Law in the Faculty of Commerce. It was constituted into a fully-fledged Faculty of Law in 1970 and has evolved steadily from the small department to its current status as a hub of legal scholarship and a champion provider of legal education in East and Central Africa.

This Handover Report outlines the key achievements realized by the School between December 19, 2016 and May 4, 2021 (four years and four months) when Prof. Kiarie Mwaura was the dean of the School of Law. The report outlines the key milestones achieved under the following heads: prizes and awards; establishment of centres of excellence; curriculum implementation and reforms; Council of Legal Education (CLE) accreditation; number of graduates; recipients of UoN LLM scholarships; new prizes and awards; staff development; launch of the law chapter of the UoN Alumni Association; participation in moot competitions; greening of Parklands Campus; grants and partnerships; conferences, workshops, and seminars; journal publications; deanship elections; work in progress; and staff establishment.

Appreciation goes to all the staff, previous deans who laid a strong foundation for the School, university administration, students, alumni, partners, and other stakeholders for their immense support during the transformational journey of the School.

1. Prizes and Awards

(a) CB Madan Prize

In 2020, the post-doctoral legal scholars of the University of Nairobi's School of Law were awarded the 8th CB Madan Prize of 2020 for their commitment and outstanding scholarly contribution constitutionalism and the rule of law. The recipients of the prize were the 124 Bachelor of Laws alumni who attained their Doctor of Philosophy degrees (PhDs) between 1970 and 2020. The CB Madan Prize is awarded by the Platform Magazine to individuals who have demonstrated significant effort to support constitutionalism and the rule of law. It is the most prestigious legal award in the country and former recipients of the award include: Hon. Chief Justice David Maraga (2017); former Chief Justice Willy Mutunga (2016); Hon. Lady Justice Mumbi Ngugi (2018); and Hon. Mr. Justice John Michael Khamoni (2015).4

(b) Theatre of the Absurd

Theatre of the Absurd is an innovative theatre club of the School that is geared towards enhancing and deepening the understanding of the law. Within six months of its formation and launch in 2019, the group produced the winning play at the 60th Kenya National Drama and Film Festival held in Bungoma County from 3rd to 13th April 2019. At this festival, the group won a total of ten (10) awards, which are: the National Winning Play of 2019; Best Play in English; Best Production; Best Scripted Play; Most Creative Play; Best Play on Youth Responsible Health Behaviour; Most Original Play; Best Director Award; Best Actor Award (Silas Owiti); and Best Screen Advert (Runners Up).⁵

- (c) The School emerged the African Champions in the 28th African Human Rights Moot Competition held at the University of Botswana from July 1 to July 7, 2019 (Winning team: Aska Judith Amor and Rachael Mwenda).
- (d) The Young Arbiters Society (UoN School of Law Chapter) was awarded the best teamwork prize by the 2019 CPR International Mediation Competition hosted in Sao Paulo, Brazil from April 4 to April 6, 2019. The team, which proceeded to the finals alongside Harvard and Columbia Law Schools, comprised Edgar Alema, Ibrahim Godofa, and Sumaiyah Omar.

- (e) The School won the National Rounds of the White and Case Moot and represented Kenya at the International Rounds in Washington DC from March 30 to April 6, 2019 (Winning team: Clemence Wari Wangio and Sylvia Katua).
- (f) Edgar Odongo Ochieng, a law student at Kisumu Campus, won the 7th African Organization for Standardization (ARSO) National Essay Competition in November 2020.

2. Establishment of Centres of Excellence

As a follow up to the UN Sustainable Blue Economy Conference (SBEC) that was partly hosted by Kenya at the University of Nairobi in November 2018, the School secured a grant of KES 7.2 M from the Norwegian Ministry of Foreign Affairs to establish the Maritime Centre/FishForce Academy in partnership with the Nelson Mandela University (NMU). The Maritime Centre is operational and has rolled out capacity building programs on fisheries crime, compliance, and enforcement. A number of our academic staff have received specialist training at the NMU in Port Elizabeth, South Africa and they have trained others, including the University of Nairobi security staff who were trained on witness statement taking.

The UN Sustainable Blue Economy Conference was the first global conference on sustainable blue economy. Over 4,000 participants from around the world came together to learn how to build a blue economy that harnesses the potential of our oceans, seas, lakes and rivers in order to improve the lives of all (project leaders: Prof. Musili Wambua and Dr. Akunga Momanyi).

3. Curriculum Implementation and Reforms

To optimize student learning, engagement, experience and outcomes, the following reforms were undertaken:

- 1. Senate Approval of the LLB Curriculum (2021 2026) for Parklands Campus. The new course units introduced include: life skills, moot court, civil procedure, criminal procedure, conveyancing, professional ethics, advanced legal writing and research, trial advocacy, entrepreneurship, law and language, law and economics, sports and entertainment law, food law and policy, criminology and penology, African justice system, and law in transdisciplinary context. (Date of Senate Approval: January 20, 2021).
- 2. Senate Approval of the LLM Curriculum (2021 2026) for the three campuses. The new course units introduced include: theories and foundations of human rights, Islam and human

rights, citizenship and human rights, regulation of reproductive health rights, international labour regime, comparative regional human rights system, business and human rights, sexuality and the law, law and biotechnology, regulation of e-commerce, spectrum management policy and regulation, entertainment law, oil and gas law, climate change and the law, environmental governance for sustainability, water resources law, law and ethics, commissions and governance, law and regulation of civil society, sports law, regulation of food for sustainability, governance and regulation of health services, financial services law, Islamic financial and commercial law, and public finance management law. (Date of Senate Approval: March 3, 2021).

- 3. Senate Approval of the PhD Curriculum (2021 2026) for the three campuses. The following new taught course units will be offered: critical legal thinking, research methodology, legal theory, research proposal development seminar, data analysis in legal research, and research writing and publication seminar. (Date of Senate Approval: April 21, 2021).
- 4. Senate Approval of the LLB Curriculum (2018 -2023) for Kisumu Campus on September 11, 2018. Two new niche course units were introduced, namely: Fisheries Law and Contemporary Socio-Legal Issues in Development in the Lake Regions.
- 5. Commencement of the LLM programme in Mombasa and Kisumu campuses.
- 6. Due to the Covid-19 pandemic, the School transitioned to online teaching, learning and examinations with effect from May 18, 2020. A lawsuit challenging online learning and examinations at the UoN was determined in favour of the University.⁶
- 7. Synchronization of teaching and examinations in Parklands, Mombasa and Kisumu campuses.
- 8. Full transition from the old to the 2013 curriculum.
- 9. Formulation and implementation of a new strategic plan.
- 10. Rolling out a mentorship programme for student leaders.

4. Council of Legal Education (CLE) Accreditation

The CLE is mandated under the Legal Education Act No. 27 of 2012 to regulate legal education and training in Kenya and to license legal education providers. It does this in conjunction with the Commission for University Education.

- 1. School of Law (Parklands Campus) License, 2021 2025. The five year license was granted on December 10, 2020.
- 2. School of Law (Kisumu Campus) License, 2018 -2023. Prior to securing its current license, Kisumu Campus had been required to teach out its students and close down due to its non-compliance with CLE conditions. To reverse this, we relocated the Campus from the Mega City Building along the Kisumu-Nairobi Highway to the University of Nairobi owned Complex in the Kisumu Central Business District on Oginga Odinga Street. In addition, we constructed additional floors, expanded the library and library resources, increased ICT facilities, expanded students services and support, established more recreational facilities, constructed a new moot court, created more office space for lecturers, and recruited more lecturers.
- 3. School of Law, Mombasa Campus, Application for renewal of license submitted in March 2021.

5. Number of Graduates

Between December 19, 2016 and May 4, 2021, the School graduated a total of 2412 students as shown below. During this period, there was a great improvement in the number of students attaining first class honours degrees, with a record high of seven (7) students in 2019 and a similar number in 2020. Most of them have secured full LLM scholarships in Ivy League universities, including Harvard, Stanford, Cambridge, and Oxford University.

The number of students graduating with second class (upper division) has also grown tremendously. Traditionally, the School has had more students graduating with second class (lower division) than those graduating with upper division. This trend has been reversed as seen in the graduation figures of 2020 when 306 students graduated with second class (upper division) against 184 with second class (lower division)

The School has also grown its Bachelor of Laws (LLB) graduation list to a high of 606 in 2018 from 580 in 2016. Similarly, the graduation list of the Master of Laws (LLM) programme grew to a record high of 105 in 2019 from 79 in 2016. The PhD graduation list is at an average of two (2) graduates per year.

This was supported by a grant of US\$ 35,000 (KES 3.8 M) from UNEP and \$45,000 (KES 4.9 M) from IDLO (project leaders: Prof Patricia Kameri-Mbote and Dr Robert Kibugi, with collaboration from Makerere University under Prof Emmanuel Kasimbazi).

EIUC is the hub of the Global Campus network and managing institution of the European Master's Programme in Human Rights and Democratisation (EMA) and it is based in Venice, Italy; The Universities of Sarajevo (Bosnia and Herzegovina) and Bologna (Italy) coordinating the European Regional Master's Programme in Democracy and Human Rights in South East Europe (ERMA); The State University of Yerevan (Armenia) coordinating the Master's Programme in Human Rights and Democratisation in the Caucasus (CES); The University of Mahidol (Bangkok, Thailand), coordinating the Master's Programme in Human Rights and Democratisation in Asia Pacific (APMA); The University of San Martin (Buenos Aires, Argentina), the Master's Programme coordinating in Human Rights Democratisation in Latin American and the Caribbean (LATMA); The University of Saint Joseph (Beirut, Lebanon), coordinating the Arab Master's Programme in Democracy and Human Rights (ARMA); The University of Pretoria (South Africa), coordinating the Master's Programme in Human Rights and Democratisation in Africa (HRDA)⁷ (project leader: Prof. Kiarie Mwaura).

JURIST staffers come from 13 different law schools in the US, UK, India, and Kenya making JURIST a collaborative global service that brings broad-minded law students together. Through the partnership, a number of our students have been engaged to perform a pro bono public service for readers around the world. This has helped them develop numerous skills vital to the practice of law, including research, analysis and writing, working under deadlines in a

team environment and developing contacts within the legal profession. The Jurist, which began in Pittsburgh as an independent non-profit corporation in 1996, has a prominent social media presence and its web services alone (not counting social media) draws over 1.3 million readers per year. Beneficiaries of this program include: Esther Chihaavi, Michael Chege, James Mbugua, and Rogers Andagalu (project leader: Prof. Kiarie Mwaura).

- Partnership with the Platform Magazine Partnered with the Platform Magazine to promote legal scholarship amongst students and staff. The editor in chief of the Platform Magazine, Hon. Gitobu Imanyara, is a human rights lawyer, journalist, politician, second liberation hero, and our alumnus, who has been instrumental in promoting the rule of law in the country for more than three decades. Many students who studied law in the 1980s and 1990s attribute their career choice to the Nairobi Law Monthly Magazine, which Gitobu Imanyara founded in 1987. The world leading peer-reviewed lawyers' directory, Chambers and Partners, rates Dr. Kariuki Muigua as one of the best alternative dispute resolution experts in the country. It describes him as 'a highly respected arbitrator and mediator with a sterling background in commercial and constitutional cases, as well as matters relating to the environment and natural resources.' 16. Work in Progress

- 1. Pending MoUs Emory University School of Law.
- 2. Refurbishment of the Lecture Theatre. A leading law firm has promised to refurbish the Parklands Campus lecture theatre at a cost of KES 10M.
- 3. The School has initiated discussions with the International Committee of the Red Cross (ICRC) on the prospects of a joint publication in International Humanitarian Law (IHL). This initiative promises to increase the participation of the African scholar in the space of international humanitarian law. An MOU is currently being prepared by the ICRC to formalise the collaboration. The School will be responsible for all aspects of the journal and ICRC will finance 75% of the operational costs.
- 4. Partnership between the Communication Authority of Kenya and UoN to support the establishment of a centre of excellence in Telecommunication and ICT Law. The centre seeks to support the work of the Communications Authority of Kenya and other agencies across the region through capacity building programmes and research.
- 5. Fundraising for the School of Law Tower.
- 6. Follow up on the pledges from the tracer study.
- 7. Development of executive courses and consultancies for the purpose of diversifying revenue streams.

17. Staff Establishment

The key milestones in this report were achieved as a result of the concerted team effort of the staff in the School. During the reporting period, the School

sadly lost two of its most dedicated and long serving lecturers, namely Dr. David Gachuki and Dr. Yash Vyas.

As more staff continue to pursue further education, we note that out of the 102 teaching staff, 47 of them (46%) have attained doctor of philosophy degrees. This is assumed to be the highest concentration of post-doctoral legal scholars in one academic unit in the East and Central African region, a factor that makes our academic programmes unique and attractive given that the intensive post-doctoral research of the Faculty enriches the teaching on offer.
