MOTOR TOPICS

CHASSIS MAINTENANCE.

Hints on Simple Running Adjustments.

OWNER-DRIVER'S WORK.

A vehicle would be useless if it were not equipped with a chassis measurement system for the purpose of adjusting the chassis to the road surface. It is the owner-driver's duty to see that the chassis is properly adjusted to the road surface. This is especially true in the case of a motor car which is used for long distances. The chassis should be adjusted to the road surface in such a way that the car will run smoothly and easily over the roughest of roads. This is done by adjusting the suspension, the steering, and the brakes. The suspension should be adjusted so that the car will not bounce or shimmy.
