

### THE OLYMPIA MOTOR SHOW.

Improvements in the New Models.

### FREEWHEEL DEVICE WHICH SAVES PETROL.

Promise of Unprecedented Business in British Cars.

[BY W. WILKINSON.]

Hughes, Oct. 13.—There was a big attendance at the Olympia Motor Show when the twenty-first Motor Show was opened at Olympia on Saturday. The exhibition and 615 models are on view which are officially registered. The number of motor vehicles on the road has increased by 10 per cent. in the last year, and the car market has risen from £1,000,000 to £1,200,000.

Manufacturers generally have improved design and equipment since the new light six-cylinder cars have come into general use. The 1½-litre cars are increasingly seen on the roads.

Automobile manufacturers such as Morris, Austin, Standard, and others, are taking advantage of a break in the market to release themselves from over-production. This is a natural result of the representations of the Ministry of Transport, which has been doing its best to simplify moving by road. The Ministry has issued a circular to all departments in order to keep the latest developments of the system of road signs and markings for motor roads.

The Ministry has also issued a code of trade ethics, Southern Africa, and other countries, in practice, which will be followed by a few examples of its use. The manufacturers of motor vehicles are asked to make a full report of the results of the experiments.


