

Efforts to Combat the Locust Menace.

RECOMMENDATIONS BY THE ADVISORY COUNCIL.

Cost of Investigations.

ALL COUNTRIES CONCERNED TO BE INVITED TO CONTRIBUTE.

Following the review, published yesterday, by the Economic Advisory Council on Locust Control, on the focus of attention in Africa and Western Asia during the year ended July 1931, the report gives a series of recommendations for the carrying on of the work of investigation.

The cost of the work involved it is stated should be borne by all means of members of the international family of nations. It is hoped that Countries concerned will continue to contribute as in the past, while others will be invited to co-operate both financially and in the furnishing of reports on the situation.

The widest possible distribution of the report of the Council is recommended. Foreign Governments it is suggested, should receive copies along with an expression of hope that they will co-operate in the locust investigations.

Reports and Information.

The Economic Advisory Council found little evidence of the continuation of the work of investigation in Africa and Western Asia (published in the "E.A.S." of June 26, 1931) and recommended that the Council should


