The Native Tribunal System is being implemented in the reserves. The effects of the ordinance are being closely monitored, and efforts are being made to reach a basis of agreement.

#### 3: Conventions.

Having in an earlier article described conventions as unwarranted to some no complete without them. I must now admit that there are two conventions of which I am a firm defender. The first is the "strong two" (of a suit) or "the hand that waltz in forced rumples" from the defender's partner. The "strong two" must be made when a hand contains not less than five and a half "spick" tricks and the most responsive bids into one of two bids; either two no trumps, or a bid of two in the suit in which you spick trick, or a call of a suit containing "strong two" tricks.

The important point is that the defender's partner, on the other hand, should not be held to bid. European evidence was heard by the Kenya Land Commission at Kyambu yesterday when Mr. W. McEllellan Wilson and Mr. Tat gave their views on the claims put forward by certain of the Kikuyu witnesses.

Mr. W. McEllellan Wilson presented a memorandum explaining the situation of land occupation in the Kyambu area in 1902 when he first had personal knowledge of the district. He stated that in 1902 when he took up his present farm there were only Kikuyu nearer than three or four miles, and they were only the adventurous of the tribe.

The land beyond Kyambu, and through Kamiti to Ruiru was originally in the hands of the Masai and there were well evidences of their occupation in the form of cattle tracks and manvatis. Mr. McEllellan Wilson stated other substantiation to support this contention.

Mr. McEllellan Wilson added that the Kikuyu only began to occupy the land in the Kyambu district between the years 1903-5, having migrated there from the north beyond the Ohantia. More Kikuyu came down from the uplands as European settlement increased.

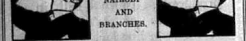

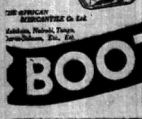
