

MUNICIPAL MATTERS

Reports Considered

THE QUESTION OF THE SHORT-
AGE OF MILK

The Nairobi Municipal Committee held its monthly meeting on Tuesday, May 7, in the Council Chamber, Nairobi, Mr. H. G. Gabriel, the Mayor, presiding, occupying the chair. Other members present were Messrs. Beaufort, Vincent, Tait, Wood, and Riddell, Councillors; Mungo, das, Dauai, and Naasani.

The Town Clerk, and Town Engineers were also in attendance.

MILK SUPPLY.

In the course of this meeting, the chairman stated that the following letter had been received by the Municipal Council from the Director of Agriculture:-

Department of Agriculture,
Nairobi, May 1, 1918.
Hon. the Acting Chief Secretary,

With reference to your letter number S/76/2/15 of 8th instant.

If the Municipal Committee can understand that the Nairobi Milk Supply Station carry out the sale of same at £2. per gallon, will adduce all accounts, and say nothing to the effect that it is necessary to be opened under the control of this Department, and arrange the return of all milk to the said station, and send down milk from the King's cattle now kept at Nairobi.

This was an emergency and temporary measure.

It is proposed that a committee be appointed with a sum of £100 to be used in cans, etc., etc., and pay for native labour, white supervision, etc.

The amount of supplied would probably be at first 20 to 30 gallons, increasing as time went on to 50 gallons.

As the Nairobi Municipal Council would have to do all the retail and collecting work in Nairobi, this Department would be asked to see that the supplies are £2. per gallon.

The proposal was unanimously agreed upon, and the Council proceeded to other business.

Southern Life Association
GRATIFYING REPORT MADE AT ANNUAL MEETING.

The twenty-seventh ordinary General Meeting of Members of the Southern Life Association was held in the Chief Office, "Southern Life Building," Nairobi, on Monday, 10 March, 1918. Sir Frederick H. P. Chairman of the Board of Directors, presided, and there was a good attendance of Members.

The Chairman addressed the meeting as follows:

In moving the adoption of the twenty-seventh report of the Southern Life Association, which was adopted for the year ending 31 December, 1917, I present to you the annual Report of the Board of Directors to your year ending 31 March, 1918, the figures from which you will gather that the year 1917, as at the close, was a very successful one for the Association, and that we have more than ever. Notwithstanding the difficult conditions under which business has had to contend, the Association has made a great and rearrangement of Head Office, a new policy, and a new up-which Policyholders may well congratulate themselves, has been the outcome of the twenty-seventh year.

Though a comparatively young Company, the "Southern" has been able to bear its share of the burden of the war, and to King and Country at a time of almost certainty in the great struggle for liberty. The Association has done its best, and responded to the call of the State, and more than a third of a million of our funds have been given to Government service. Your Directors are satisfied that in arranging for these facilities they have done their duty, and that the desire of Policyholders to follow a patriotic course, State and Empire under whose protection the Association has its property and is privileged to do its affairs.

LIFE DEPARTMENT:

By a comparison of the statement and explanation of the facts and figures of the Life Department, it will be seen that during the year 1917, the premium income, though total sum being £1,888,249, of which £29,418,700 were declined or not taken up, so that the actual premium income was a new but still very large sum of £1,105,100, whereas £1,229,540, the annual premiums therefore, increased to £44,851.

In the year 1917 the new business accepted and completed amounted to £1,229,540, the premium income received being £43,800. During the year 1917, the new business accepted by 266 policies, with £105,800 in sums insured, and £10,451 in premiums. Under the new system of rating, the rate of premium is even more so than before, and the new premium income exceeds by more than 44 per cent. the premium income received in any previous year of our history.

Special mention must be made of the Malawi Province Liquor License Office, which will sit at the District Commissioner's office, Nyeri, on Friday, June 10, at 10 a.m., A. Right Hon. Sir P. N. Venetiaan, Minister of Home Affairs, will be present, and the new premises will be open to the public on that day.

The total amount of new business was £213,345, as compared with £109,107 in the preceding year, and the amounts shown that out of the total £109,107 was collected in 3 per cent. of the total to be collected.

During 1917 we collected in 3 per cent. of the amounts due, and the annual statement will be published in 1918. This is particularly gratifying.

The new business received within the year, for which £1,229,540 was received, being a slight reduction in amounts as compared with the previous year. Premiums for policies who require an assured sum, and those who desire that others should have it for life, are also now available. The new system of rating this kind of provision deserves much attention than it has yet received. An analysis of the new rates of premium is given, and the amounts are provided to meet the requirements of the new system. INTEREST:

Our interest in the Life Branch amounted to £80,400, being an increase of 80,740 over that of 1916. INCOME TAX:

Once more it is necessary to note with

regard to the Income Tax that continues to be paid to the Treasury, but it will be observed that the amount of tax paid has been reduced, the last Income Tax Act having decreased the percentage payable, and allowing for the deduction of the amount of tax received from investments. While general for this, nevertheless, belief is held among the Members alone, we cannot approve of the principle of taxation, and believe that the same would be better if delivered us from the tax entirely.

It was hoped that during this session of Parliament the Income Tax would be abolished from the payment of the large amounts of money demanded as tribute to the Government of South Africa, but such legislation appears to have been shelved for the present. We are anxious to see that the amount of money entreated to us should be speedily produced by the representatives of the people, and that the same should be used for other purposes, and that every obligation may be fully met as it arises, free contributions in computing the amount of tax for heavy taxation has not been adopted.

COAST RAINFALL

Pleasant but Unseasonable Spell of Dry Weather

(From Our Own Correspondent)

MOMBASA, May 15.—The rains which have come in like a racing lion and were dispersed last week with the sun have returned again. The question is whether there is to follow an adequate rainfall to give further encouragement to the cotton-growing and the native crop growers—who have been killing the ground in readiness for the next sowing. The work of the cotton planting has been done along the Coast in maize, rice, millets, etc., but if there is no rain the cotton will not grow and the look will not be bright. While the rains at Mombasa have been fair, those at Voi and Kilifi have been far from so. It is felt that the fall at Voi has been much greater. There seems to be a certain discrepancy of rainfall between the two stations. On the average there might well be an urgent need shortly for a more heavy supply of water to the cotton fields. The unseasonable spell at Mombasa is unacceptable. The country looks charming and the food and drink are excellent. The native houses however should note, by the way, that the juicy green tops of the melons make delicious salads.

Upon enquiry as to the amount of rainfall received since the beginning of the initial spell, we find that nearly six inches of rainfall have been registered, so far as Voi is concerned, while at Kilifi (20) there were 14½ inches registered and the first five or six days of May contributed a further 10 inches. This is all that is needed to bring the cotton crop into full flower.

LEAVING EMPLOY.

Martial Law Cases
TWO CONVICTIONS IN MAGISTRATES COURT

In the Mombasa Magistrate's Court yesterday, before Mr. Bishop, two cases of special interest were tried, in which the law of martial law was involved. The Law Regulator, which says, in effect, that no man may leave his employment without the permission of the War Council or a District Commissioner.

Specie Thieves Convicted.

GOVERNOR AND MRS. CORYM-
DON VISIT KAMPALA

(From Our Own Correspondent)

KAMPALA; May 8.

If the Governor and his Considine arrived here yesterday, they had to be with us for a week, during which time a number of guests will be entertained by them.

We hope the present will be removed shortly, and we expect to be entertained here for a Government India.

His Worship, Mr. Homes, delivered judgment yesterday in what is known as the Corporation of Uganda case. Four accused named, Bhaw Singh, Kasmali, Patel, and Valapara. The four were accused of two years rigorous imprisonment and a fine of Rs. 1,000/-, and each was fined Rs. 1,000/- and accused second received 9 months rigorous imprisonment and all accused were sentenced to pay costs.

The reason given by the court for the prosecution was that the first accused who was a clerk in the employ of the Corporation of Uganda, was in charge of a very large sum of money taken delivery of 72 boxes of specie at his residence, and the accused were present and participated in the crime.

Great credit is due to the P. G. MacCallum, of the Anti-Sabotage unit, by whom he investigated the case and the conduct of the prosecution. Mr. Tahmud the learned magistrate presided over the trial.
