CHAMBER OF COMMERCE

Definite Attitude With Regard to
electric Light Rebate

C. I. O. FEES AND RAILWAY ROLLING STOCK DISCUSSED

The monthly general meeting of the Chamber of Commerce was held yesterday at the New Bailey Hall on Thursday evening. Mr. J. G. T. Tait, M.P., was present.

Mr. G. C. Tuckwell, M.C., who is the manager of the East African Stock Exchange, was among those who present.

Mr. W. L. Thompson, Sir H. Wood, Collier and the U.S. Standard, Mr. H. Hale and Mr. W. A. Jackson were also present.

The following letter was read from an Associated Chamber of Commerce for East Africa, a letter which contained a protest against the taxation of the pilot lights, but giving an amendment which would have been acceptable.

It was voted that all the Chambers had agreed with the proposal made by Mr. Thompson and Kinstone.

The later Chamber, however, subsequently decided to leave the question open and give a final decision when the matter was discussed again.

The following letter was read from the Montevideo Chamber of Commerce:

Dear Sirs,—I am sending you two letters of the 5th March, and in one I say I am instructed to arrange a committee meeting.

Will you please advise us of any arrangements you have made.

In regard to the working of Railways in the present War Departmental Control, Capt. J. W. T. H. Thompson has given every possible measure to improve the conditions.

FREIGHT RATES

Frequent rates were the subject of some discussion and it was voted that the matter be referred to a committee appointed by the proprietors of the Standard.

The Secretary informed that the-pricing system was still in operation and that the rate from Nairobi to Mombasa on March 28 is £1.30. In the committee, Mr. H. Hale and Mr. W. A. Jackson proposed to recommend to the government a reduction to £1.00 per ton per mile.

Mr. W. A. Jackson, in his report, mentioned that the recent increase in the cost of the railway with regard to the carriage of goods had been due to the fact that the Company had only received a formal reply acknowledge that they could not have increased their charges.

The Secretary informed the meeting that the Kenya Government had requested the Company to make a further reduction in the rates of freight.

The following letter was read from the Chamber of Commerce with regard to office complained:

Mr. E. H. Thompson, the Secretary of the Chamber of Commerce, addressed his letter of 25 April to the Director of Posts, Nairobi, asking him to take steps to have his letter put before His Excellency.



OUTLYING DISTRICTS

Mr. Editor, S.A. Standard.
Will you kindly inform us of the
present meetings about the
possible beginning to come of
the construction of hospitals for the
various war memorials for East
Africa? So far as we understand
the position at present:

(1) and (2) mentioned. Natives will (3)
attempt to make up the deficiency by

Nairobi (4) to recruit purely local memorials.

This is our opinion, and we are anxious in
arriving at the first of these
three choices as to urge the members
of the public to give their support to the
hope that Nairobi will even now
endeavour to demonstrate still
more the third choice.

The two main arguments presented
are that the native contribution sufficient
money cannot be found and that the ideal is selfish with regard
to the natives. We do not consider the
ideal as being irreconcilable, but we do not believe in
the true representation of Nairobi

This is our belief, and we entirely
desire to do what we can for the
whole community afforded by the
same place as the presents Nairobi.

This is our belief, and we desire
such and expect such a response
from the whole community as
much as subordinates would be aiming
to bring up the proposed

memorial. We are not
lastly do we believe that those who
have given up their money to the
cause will be more than compensated
by a scheme, in their own estimation,
to alleviate the suffering
of the natives, and to assist
them to better health and welfare
by their deathless memory.

We quote the words of Mr. G. G. Gabriel
of Nairobi: "We question
whether the true spirit of
Nairobi hospital were known at the
time of its creation, and if so, why
had they been known, the decision
might have been different."

We therefore urge with all our
force that the people of Nairobi in
Nairobi as the combined
representatives of the British and
its daughter districts should

in a position to fully
discuss the matter before
joining with Nairobi if they
can. Nairobi has expressed an
