

Income Tax Raised. April 30—The Official Budget Memorandum estimates a deficit of £1,572,000.

The deficit defers between the estimated and realized income for 1908 is £1,510,000 making the total deficit £1,500,000.

The other Budget proposals are a tax on Clubs, various increases and graduations on liquor taxes and licenses.


