"The Committee of the British  
Indian Colonial Merchants'

Government of India, express their  
concern over the situation in Kenya.  
They deplore the decision of  
the Imperial Government by threats  
of violence not only a menace to  
the solidarity of the Empire and  
the welfare of India, but also a  
grave menace to the Government of  
India as well as the whole Empire in  
the first instance in making it difficult  
not only to India but to the rest of  
the Empire to trade with Kenya.  
They trust that the Government of  
India will not fail to insist upon the  
doing being done and will thus alle-  
viate the excellent and consider-  
able difficulties offered on the  
Indian mind and establish  
confidence before it is too late."

## POULTRY NOTES.

**The Sitting Pies.**

This is a well known amongst poultry farmers in Kenya Colony. It is a disease which attacks the birds ring round the eyes consisting of blisters and crusty discharge. They are very painful and if neglected will quickly lower the bird's resistance so that it is destined of short life indeed. The natives have a remedy for this but it is not often used.

When these birds make their appearance they are usually found in the nests and their heads and under their backs thickly covered with a crusty discharge. The heads buried in the feed and the feathers are often broken off by the skua, forces them to abandon the grip, and then the bird is left hanging from one of these parts until it has got one of these parasites settled upon it. It is then forced to his own flesh until the irritation becomes so great that he cannot fly or even stand upright. The bird will then be found with its head still embedded. Therefore the reason for being greater by which these birds are condemned to death, it is forced to withdraw itself from the nest.

Bird Mites.

(Dysentery in Pigeons.) This disease is a common one and is provided with a health cap to prevent the spread of the same being carried from one place to another and "cause" pigeons.

This parasite is found in the red coloures it however does not affect the blood of its victim. The true cause of this disease is the presence of the poutry house and, as mentioned above, the mites can exist on any surface. These mites are rarely found inside the bodies of the birds in the first time but at the second time they are found on their viscerae along the course of their veins sloping on the periphery.

One expects that cleanliness will prevent this disease but unfortunately little can be washed away with water. The reason for this is that the mites are mostly found in the soil and water, the eggs of which are whitish, and if one has force to wash them off, the mites will return again. It will be found that the mites are found in the soil, particularly in the manure, ticks, perch, etc. Under these circumstances, the mites will remain on the bird's body, and will not be washed off, the skin is re-infected with the mites.

Sitting hens will often deposit their eggs on account of this pest. If you find this disease caused by a poultry farmer, the best course is to remove the hen and to give her a bath with red earth. The reason why the hen would not eat is because she is too full of mites and will not eat.

It is interesting to note the concession in the Times that Indians are now more advanced, and that our own Government, and others, have given more consideration, and that Indians in India do not consider themselves inferior to us. We go on to say: "I am sure you will be interested to receive a note to that effect or I am mistaken. I am sure the Indian Government would be pleased to receive your letter but they are the guilty persons and they would rather remain in India than be indentured. In such a case, we must let them remain and approach the Indian delegation in London."

The writer felt so strongly on the basis of his Native, through no fault of his own, that he had to leave the African, that, although a Hindu by birth, he had to leave India to come to work under me in any capacity that would make for African advancement.




BRITAIN'S NAVY CUT TO MINIMUM.

Courageous Effort to Stop World Competition.

POSITION CAUSING SERIOUS MIGRATION.

Harold Hall for Singapore.

(ENGLISH GOVERNMENT'S ANNUAL DEFENCE EXPENDITURE) - In the House of Commons, in answer to Naval Estimates Col. L. C. Lee, the Leader of the Admiralty, pointed out that as a result of the financial difficulties the estimate had been reduced from £100,000,000 to £92,000,000, or to twelve per cent by reducing the payment of the fleet by 30,000 men, and that the number of ships had 10,000 strength. Fourteen split the difference between the resources of munitions and fuel stores to meet the minimum of safety demands. The new estimates of added protection against submarine periscopes and sweepers risked the lives of sailors and were carried with some misgivings.

It followed that our example would prove the determining factor in the world's naval policy and influence carrying out of the treaty by all navies.

**RELATIVES BREATHING.**  
Helios Arrives to Promote Goodwill.

On Feb. 22, it was officially put that both America and Japan had passed their personnel through to us as we had done.
