MINING REGULATIONS OF GERMAN EAST AFRICA.

Consul Mason Mitchell has sent to the United States Government from Zanzibar, January 30, 1904, regulations of the mining rules and regulations of German East Africa, in response to enquiries from the United States for information upon this subject. In transmitting the inclosure to the Consul the acting Governor says:

FATAL ACCIDENT IN MOMBASA.

COLLAPSE OF BUILDING.

Fatal Accident in Mombasa. Collapse of Building.

London July 27, 8.40 p.m. (Received in Mombasa, July 28)

The unfortunate building in course of erection facing the Law Courts has met with the fate predicted for it.

A particularly ugly structure in itself, it was in a very bad way, and an attempt was made to construct three storeys.

The third, however, proved the last straw. The building has been unfortunate from the start.

First one of the centre stories fell, injuring some men, then the building was stopped by the authorities for some time.

Now the centre front has fallen down, cracks are visible in the masonry.

It is a very serious matter, and the condition, the gharry line has been blocked, and business with the lower part of the town obstructed.

The remains of the building, instead of being levelled, are being used as a menace to every passer-by.

There is a heavy responsibility resting upon some one—upon whom it is not for us to say, the more especially as we have no knowledge as to who holds the trust in the interests of all parties.

And more especially those of the friends and relatives of the dead and injured—the equity will be a full, open account.

At about twenty minutes past twelve on Monday, apparently without a warning sound, the collapse took place.

Some men were at work on the building at the time, and it was thought that it was a coincidence about this time of the day, others were resting under the verandah on the ground floor.

Mr. Sanderson, of the Conservancy Department, who was in charge of the work, was present, and was the first on the scene.

Messrs. Gerald and Charles Anderson came running down from the Grand Hotel, and were the first to arrive.

Other early arrivals were the Bishop of Mombasa, Mr. J. A. Bailey, the doctor of H.M.S. *Arcturion*, Mr. Lofort, and several officers of the Government, including Mr. J. W. Tritton, Mr. W. J. Monson, Judge Carter and Mr. Morris Carter.

Indeed every department appeared to be represented at the street with the exception of the H.M. Customs Department, who, however, turned up later in force.

Meanwhile those who were on the scene had promptly got to work.

At great danger to themselves from the falling of the masonry, European and native—started digging away and pulling out the bodies.

As they were extracted in a dazed and maimed condition they were laid upon stretchers and carried to the Fort Hospital. Askaris had been despatched blowing whistles for assistance in every part of the town, and others had gone to search for doctors.

Dr. Clark and his assistants, who were on duty at the hospital, were called upon to attend to the sufferers, and every able bodied native—willing or unwilling—was forced into the work of rescue.

When five men had been recovered, apparently those who had been at work on the top verandah, it was thought there were still four buried at the bottom of some hundred tons of stones and earth, but the position had now become precarious for the workers.

Some heavy showers served to still further loosen the masonry, and while a rest was taken below, some of the men on the top of the building and removed the more dangerous portions.

Digging again commenced and continued until the bottom was reached, but fortunately no bodies were found.

A wise move was then made. A ding was attached to one wing of the building, and tackle attached with the object of pulling it down.

NEWS FROM UGANDA.

FROM OUR OWN CORRESPONDENTS.

The many friends of Mr. C. J. York, Assistant Collector here, will be sorry to hear that he has been laid up at intervals with some sharp touches of fever which culminated in the attack of the Blackwater, from which he has, we are glad to say, recovered.

Mr. H. Prendergast, Collector Jinja, is at Entebbe, again for a month's change, and has been suffering since he left Jinja for some months past. We wish him a speedy recovery without the necessity of being in invalided home to England.

Mr. and Mrs. F. H. Leahy have been in Entebbe from Kampala for a few days and stayed with Colonel and Mrs. Hayes Sailer at the Residency.

There have been several changes in the Medical Department lately, chiefly owing to the sad death of Doctor Stry at Musingu. Among other Doctor Haber has left Entebbe for Kisumu to relieve Doctor Walker who has been dangerously ill, but who is at the time of writing reported slightly better. Doctor Haber came from Jinja. Doctor Haber is at Entebbe temporarily. Lieutenant Tishard of the R. A. F. is at Entebbe from Jinja and will be leaving for Mbaraka. Another doctor is expected to arrive. He looks very fit, and thoroughly enjoys a good game of cricket more than any of the other players here.

Lieutenant MacLeod of the R. A. F. is also at Entebbe for a few days, on pleasure leave from his tour in Uganda. We understand he had a pleasant trip and some good shooting.

Mr. W. Fowler, Esq., C.M.E. who went to Lake Albert on business connected with the Marine Department. Mr. Fowler had some excellent sport on route, including two fine elephants.

That reminds us that the elephants in Uganda have been having a bad time of it lately. In N. O. I jagged more than one fine tusk. One was taken having tusks weighing over 100 lbs each.

Remost says that the amount of timber to be collected in that has been fixed at about 100,000 tons. It is expected that the timber will be collected in the forest for a satisfactory export.

We venture to call attention to the Uganda Railway. Notice of train and steamer services altered, being dated from August 1st appears on page 27 of the issue, and is complete July 15th. It is a very important statement which is likely to be of much interest to our readers.

As there is a post on the Lake route to Kampala from Musingu, which is between seven and eight times from Kampala, and passengers arriving at Musingu will be slightly surprised that they have an opportunity to call at seven points before they reach Musingu. It will doubtless occur that arrangements have been made to transport their goods and baggage to their destination, the same applies to passengers. As ordinary goods consigned to Kampala, we are not aware of any arrangements having been made as yet by the post.

We hear of good activities, that at least a schoolmaster with water supply, the amount of time past has been a crying need. It is proposed to build a dam on the lake, by means of which wind mill power, and also a steam power plant available to create a continuous supply of water. The dam will raise the water to a good elevation above the lake, allowing water in reservoirs and thence down the main to be carried so as to be available to irrigate all parts of the valley. All present all the inhabitants of Entebbe are being to engage natives to carry water up the hill in many cases over a distance of a mile.

We have had much pleasure in meeting Messrs. Matlons and Herrings who have lately arrived in Uganda. They are from Tanganyika and thence travelled down to Mombasa in order to have a look at the East African Protectorate, and the new route of the Uganda Railway. These gentlemen have just passed through here again on their way to Entebbe via Kisumu. We wish them luck and good speed.

Compton, who proceeded to Kampala for the purpose, many other Europeans attended and thousands of natives, who were most of them unable to enter the church and had to stand outside the doors.

LABOUR COMMISSION, TRANSYAL.

(APPOINTED BY GOVERNMENT GAZETTE OF JULY 3rd, 1903.)

IT IS HEREBY NOTIFIED for general information that His Excellency the Lieutenant-Governor has been pleased to approve of the appointment of a Commission to inquire into the amount of labour is necessary for the requirements of the Agricultural, Mining, and other Industries in the Transval, and to ascertain how far it is possible to obtain an adequate supply of labour to meet such requirements from Central and Southern Africa.

The Sittings of the Commission will commence on Tuesday week, July 21st, at 10.30 a.m. in the Municipal Council Chamber, Johannesburg, and will be open to the public.

(1) The Commission invites the attendance of all willing to give evidence, who are acquainted with the requirements of the Transval in the matter of labour for its Agricultural, Mining and other Industries, and with the amount of labour available.

(2) The Commission likewise invites the attendance of all acquainted with the native inhabitants of South and Central Africa.

The matters as to which evidence is desired are, inter alia, as follows:— (i) District with which witness is acquainted.

- (ii) Length of time during which witness has known such district. (iii) Character of Natives of such districts. (a) Usual Work. (b) Usual Food. (c) Usual Pay. (d) Physique, Aptitudes, Special Ailment (if any). (e) Special conditions (if any) affecting labour supply which would (A) induce, (B) deter from, willingness to come to Transval to work. (f) Approximate numbers available. (g) Enterprises, Agricultural and Industrial (any) managed by Europeans in such districts, and number of natives required for such enterprises.

It is requested that intending witnesses will communicate with the Secretary of the Commission, Address: Bx 2615, or 31, Plein Street, near Park Station, Johannesburg, as to their willingness to appear and give evidence, their addresses, whether notifications may be sent them; and, if possible, a short statement as to the evidence they are willing to give, specifying those points they consider of particular importance.

Witnesses whom the Commission decide to call, will receive their reasonable expenses.

It is also requested that those who know of suitable witnesses will send the names and addresses of such persons to the Secretary.

THE CLOTHING OF NATIVES.

The following notice has been issued in Nairobi.— In the general interest of the advancement of the Natives in and about Nairobi, as well as on other grounds, I am desirous of commencing an arrangement by which it shall be compulsory on any native entering the town to be decently clothed. I shall be obliged if all Europeans living outside of Nairobi who have occasion to send in natives as carriers for their purposes were to advise such natives that they must wear at least loin cloths. Missionaries and settlers could materially assist in this arrangement by encouraging the wearing of cloth by all natives in their employ, &c. Government Officers will do every thing possible to warn natives that they must clothe themselves decently when coming into Nairobi, and to assist in making arrangements when coming into the District Stations. In Nairobi itself the Police will have instructions during the next two months to warn all natives that they are not to be allowed in the town unless clothed with at least an ordinary loin cloth. On and after the 1st October 1903 any native found within the limits of the Nairobi Township area who is not sufficiently clothed will be liable to arrest and punishment. (Signed) JOSE ANSWORTH, H. M.'s Sub-Commissioner. Note.—The following dress for the present should be considered sufficient:— Men.—An ordinary loin cloth which properly covers the nakedness. Women.—The women are, I consider, sufficiently clothed at present, and they can be left to a gradual progression in dress.

TRANSVAAL.**

(APPOINTED BY GOVERNMENT GAZETTE OF JULY 3rd, 1903.)

IT IS HEREBY NOTIFIED for general information that His Excellency the Lieutenant Governor has been pleased to approve of the appointment of a Commission to enquire what amount of labour is necessary for the requirements of the Agricultural, Mining, and other Industries in the Transvaal, and to ascertain how far it is possible to obtain an adequate supply of labour to meet such requirements from Central and Southern Africa.

The sittings of the Commission will commence on Tuesday week, July 21st, at 10-30 a.m., in the Municipal Council Chamber, Johannesburg, and will be open to the public.

(1) The Commission invites the attendance of all willing to give evidence, who are acquainted with the requirements of the Transvaal in the matter of labour for its Agricultural, Mining and other Industries, and with the amount of labour available.

(2) The Commission likewise invites the attendance of all acquainted with the native inhabitants of South and Central Africa.

The matters as to which evidence is desired are, inter alia, as follows:—

- (i) District with which witness is acquainted.
- (ii) Length of time during which witness has known such district.
- (iii) Character of Natives of such districts.
 - (a) Usual Work.
 - (b) Usual Food.
 - (c) Usual Pay.
 - (d) Physique, Aptitudes, Special Ailment (if any).
 - (e) Special conditions (if any) affecting labour supply which would (A) induce, (B) deter from, willingness to come to Transvaal to work.
 - (f) Approximate numbers available.
 - (g) Enterprises, Agricultural and Industrial (if any) managed by Europeans in such districts, and number of natives required for such enterprises.

It is requested that intending witnesses will communicate with the Secretary of the Commission, Address: Box 2047, or 31, Plein Street, near Park Station, Johannesburg, as to their willingness to appear and give evidence, their addresses whether notifications may be sent them; and, if possible, a short statement as to the evidence they are willing to give, specifying those points they consider of particular importance.

Witnesses whom the Commission decide to call, will receive their reasonable expenses.

It is also requested that those who know of suitable witnesses will send the names and addresses of such persons to the Secretary.

**LABOUR COMMISSION,
TRANSVAAL.**

(APPOINTED BY GOVERNMENT GAZETTE OF JULY 3rd, 1903.)

IT IS HEREBY NOTIFIED for general information that His Excellency the Lieutenant-Governor has been pleased to approve of the appointment of a Commission to enquire what amount of labour is necessary for the requirements of the Agricultural, Mining, and other Industries in the Transvaal, and to ascertain how far it is possible to obtain an adequate supply of labour to meet such requirements from Central and Southern Africa.

The sittings of the Commission will commence on Tuesday week, July 21st, at 10-30 a.m., in the Municipal Council Chamber, Johannesburg, and will be open to the public.

(1) The Commission invites the attendance of all willing to give evidence, who are acquainted with the requirements of the Transvaal in the matter of labour for its Agricultural, Mining and other Industries, and with the amount of labour available.

(2) The Commission likewise invites the attendance of all acquainted with the native inhabitants of South and Central Africa.

The matters as to which evidence is desired are, inter alia, as follows:—

- (i) District with which witness is acquainted.
- (ii) Length of time during which witness has known such district.
- (iii) Character of Natives of such districts.
 - (a) Usual Work.
 - (b) Usual Food.
 - (c) Usual Pay.
 - (d) Physique, Aptitudes, Special Ailment (if any).
 - (e) Special conditions (if any) affecting labour supply which would (A) induce, (B) deter from, willingness to come to Transvaal to work.
 - (f) Approximate numbers available.
 - (g) Enterprises, Agricultural and Industrial (if any) managed by Europeans in such districts, and number of natives required for such enterprises.

It is requested that intending witnesses will communicate with the Secretary of the Commission, Address Box 2645, or 31, Plein Street, near Park Station, Johannesburg, as to their willingness to appear and give evidence; their addresses whether notifications may be sent them; and, if possible, a short statement as to the evidence they are willing to give, specifying those points they consider of particular importance.

Witnesses whom the Commission decide to call, will receive their reasonable expenses.

It is also requested that those who know of suitable witnesses will send the names and addresses of such persons to the Secretary.
