Sir:—

I am directed by Secretary Sir E. Grey to acknowledge the receipt of your letter 45028 of the 30th ultimo respecting the establishment of an International River Board of Representatives of Great Britain and Italy to settle the question of the Juba River boundary and also questions of irrigation and navigation as they arise.

I am to state for the information of the Secretary of State for the Colonies that Sir E. Grey is willing to approach the Italian Government in the matter as desired by the Governor of British East Africa.

I am however to point out that the Italian Government may take the opportunity to raise afresh the question of wireless communication between British East Africa and the Benadir and may be unwilling to meet the wishes of His Majesty's Government in regard to the

establishment of the proposed Board unless His Majesty's Government are able to agree to the measures necessary to connect the Benadir Coast and British East Africa by wireless telegraphy.

I am therefore to suggest for the consideration of the Earl of Crewe that in view of this contingency and of the statements contained in Colonel Montgomery's report §§ 6 and 13 as to the value of the district of Jubaland and the necessity for the establishment of wireless telegraphy to connect it with the Benadir and Mombasa, it might be expedient to approach the Treasury again in regard to the matter (see your letter <sup>to</sup> 45348 of the 31st. ultimo).

Sir,

I am &c. to ack. the recd. to your letter of the 3<sup>rd</sup> Jan., no. 15026/08, on the subject of the establishment of an *International River Board to settle certain questions connected with the Juba River.*

You state that the Italian Govt. may take the opportunity to raise afresh the question of wireless communication between the L.A.P. and the Benadir, and you suggest that it might be expedient to approach the Treasury again in this matter.

It will be seen on reference to the letter from this Dept. of the 21<sup>st</sup> Dec. that Lord Crewe does not think that the interests of the L.A.P. are sufficiently concerned to justify him in pressing the L.C. of the Treasury to sanction expenditure on this installation, and he would again suggest that <sup>Secretary</sup> Sir H. Grey should approach the Treasury in the matter, traversing the argument contained in the Treasury letter of the 3<sup>rd</sup> Dec. that the convenience of the installation to the Italian Govt. would only be a temporary one, assuming that the argument is not in fact valid.

Lord Crewe would be glad if, irrespective of this question of wireless communication, Sir H. Grey would approach the Italian Govt. on the question of the

regulation of the Juba River, & since the conclusion of such an arrangement would be of equal advantage to both nations, ~~it is~~ <sup>and</sup> an agreement on the subject can ~~be regarded~~ <sup>be regarded</sup> as a concession to be granted in return for expenditure on wireless telegraphy by I. I. G.

I am to add that, should the Italian Govt. decline to proceed with the Juba R. negotiations on this ground, which Lord Crewe ~~can~~ <sup>would</sup> only regard as ~~an~~ <sup>unreasonable</sup> ~~unreasonable~~, ~~or~~ the fact might be used as an additional argument in approaching the Treasury on the question of wireless communication.
