Grey concurs in the view of the Earl of Crewe that an amendment of the Zanzibar Order in Council of 1906 is necessary in order that a person sentenced at Zanzibar may be detained at Mombasa, and I am to transmit to you herewith for Lord Crewe's observations a Draft Order in Council dealing with the matter.

DRAFT ZANZIBAR ORDER IN COUNCIL.

WHEREAS by treaty, grant, usage, sufferance, or other lawful means His Majesty the King has jurisdiction within the dominions of His Highness the Sultan of Zanzibar :

Now, therefore, His Majesty, by virtue and in exercise of the powers in this behalf by "The Foreign Jurisdiction Act, 1890," or otherwise in His Majesty vested, is pleased, by and with the advice of his Privy Council, to order, and it is hereby ordered, as follows :—

1. This Order may be cited as "The Zanzibar Order in Council, 1909," and shall be read as one with "The Zanzibar Order in Council, 1906" (hereinafter called the principal Order).

2. The following article shall be substituted for article 21 (1) of the principal Order :

"Where an offender convicted before the court is sentenced to imprisonment, and the Court, proceeding under section 7 of 'The Foreign Jurisdiction Act, 1890,' authority in that behalf being hereby given to it, considers it expedient that the sentence shall be carried into effect elsewhere than in Zanzibar, the place shall be a place in the East Africa Protectorate, or a place in some part of His Majesty's dominions out of the United Kingdom, or in one of His Majesty's Protectorates, provided that the Government thereof consents that offenders may be sent thither under this article."

3. Article 21 (1) of the principal Order is hereby repealed.

And the Right Honourable Sir E. Grey, Baronet, one of His Majesty's Principal Secretaries of State, is to give the necessary directions herein.
