Sir,

I have laid before the Lords Commissioners of His Majesty's Treasury Mr. Fiddes's letter of the 7th instant (19760/1911), respecting the terms on which it is proposed to appoint the Government Analyst for whom provision is made in the Estimate of the East Africa Protectorate for the current financial year.

In reply I am to state that My Lords will not object to the assignment of pension rights to this post, on the understanding that Mr. Secretary Harcourt is satisfied that it will be permanently required, and provided that any appointment to it is subject to a period of probation.

As regards the salary to be assigned to the pensionable position, however, Mr. Harcourt is aware of Their Lordships' views regarding the reduction of effective emoluments on the grant of pension rights. In the present case They understand that the officer referred to in the last paragraph of the letter under reply is at present in receipt of salary at the rate of £300 a year and in these circumstances My Lords are not without hope that a pensionable scale of £400 by £20 to £450 might prove sufficient to attract him. While therefore They are not prepared definitely to object to the remuneration recommended by the Secretary of State, should he be satisfied that

the services of the gentleman in question cannot be obtained for less, They trust that every endeavour will be made to keep the emoluments of the post within the limits I have named.

I am directed by His Secretary Harcourt to inform you that, subject to your being passed as physically fit for service, he proposes to select you for probationary appointment as Government Analyst in the East Africa Protectorate, with salary at the rate of £400 p.a., and £10 rising by annual increments of £20, to £450, and quarters free of rent (but not of rates or similar outgoings) or an allowance in lieu.

2. A memorandum showing the general conditions attached to appointments in the Protectorate and a copy of the leave and passage regulations for civil officers are enclosed herewith, but you are to understand that you will be subject to any regulations which may hereafter be introduced by or with the sanction of the Secretary of State. A copy of the regulations as to pensions and a copy of the Colonial Regulations are also enclosed.

3. If you are prepared to accept the appointment on the above conditions, you should present yourself <sup>without delay</sup> to one of the medical officers of this Department, whose names are given on the enclosed letter, for the purpose of being medically examined. The letter is to be left with him, and you will be required to pay him a fee of one guinea. He will send his report direct to this Department.
