Jenney memorial

Submit further report on Lady Jenney's proposals for removal & recreation

This is the first reference to a Memorial Building. We were under the impression that the Memorial consisted of (1) water tanks for cattle (2) Marble slab with inscription.

The water tank for cattle is to be done away with. A drinking fountain is to be built under the Memorial Building which is to be re-erected as a portico to the Baraza.

The marble slab on the Building will be removed and the inscription altered (as suggested by Lady Jenney (39262))

The inscription should be in Arabic and English as before, and we should tell the Govt so when we reply.
