We authorized C.O. to pay his gratuity here as he asked for it verbally (immaterially). The gratuity is assessed correctly. (23421/18) C.O. has not issued a book report & must do so before we reply that he is not entitled to a bonus in respect of his services in the local areas and that he is not being granted one; that as a W.D. class 26 he is eligible for a war gratuity of £30.00.0 under the Act of 11th December 1918 in respect of his services in the local areas for the period 20/7/18 (49215/18) to 30.12.18, that in accordance with his request C.O. has been asked to cause his gratuity to be paid to him in C.A. on his return there that it will not be paid by C.O.

Army and am fully entitled to it. I am as other members of my unit. for instance a Corporal's gratuity for 3 years 280 days is approximately 630 dollars for my service I should receive more and above that and according to rank, I have been offered \$30.18 which I have not accepted.
