# EXTRA-MURAL STUDY AT MAKERERE

## College courses planned



**Arrangements** are being made to start extra-mural departments at Makerere College, the University College of East Africa. The intention is to provide courses in the college and in other centres in Uganda. The college authorities will eventually arrange for an extension of this work to their territories.

The general purpose of the new courses is to extend the work of the college outside its walls, to widen the application of the principles and quality of education given at the college, and to teach people who are unemployed or attend normal courses at Makerere.

It is intended to found extra-mural departments in Uganda for the meetings and study classes which are now held on weekends and holidays.

### Experimental



## KENYA MEMBERS CHALLENGE RAIL COSTS

### Amendment ruled out of order ESTIMATES DEBATE

TWO Kenya members of the East African Central Legislative Council — Mr. K. M. Keyer, former leader of the European Unofficials in the Central Legislative Council, and Mr. R. B. Pandya — yesterday challenged the decision of the Transport Advisory Council to increase rail-way freight charges by 20 per cent from the start of this year.

When they debated on the Railways and Harbours Amendment's draft estimated started at the Assembly meeting in Nairobi, they proposed and seconded an amendment to the bill of order that the increase should be cut to ten per cent.

In a long address, Mr. Keyer alleged that the Assembly had been used to "cipient and deserved and undeserved" reasons. Because Ministers did not investi-

gated problems which came before them. He criticised the manner in which the estimates had been presented by the Acting Commissioner for Transport, Mr. A. E. Kirby, and the general manager of the Railways and Harbours Commission. They were described as "unconstitutional" and had "reduced the deliberations of this Assembly to a farce."

Mr. Keyer then attacked the general manager of the Railways and Harbours Commission for his "lack of interest" in the committee.

Mr. Keyer said he had "great respect" for Mr. Kirby, but that it was not right that he should be an "isolated figure" in the new "island." He added: "I am asking you to give attention to services and possibly introduce a system of transport service which would complement the movement of these articles."
