



Blind Scientist's African Journey

STUDYING RELATIONS OF BLACK AND WHITE

Big Problems Ahead

GRAVE DISASTER IF EUROPEANS HAD TO LEAVE AFRICA

A Doctor of Philosophy, blinded on war service, a woman driver and co-worker, with close-cropped hair and a trim, boyish figure, and William, an African servant, set off yesterday on a raw, grey February morning to drive to Cape Town and to observe the customs and manners of mankind as they travelled.

The two were returning to their own country, South Africa, using a well-loaded "International" 15 cwt. light truck. They were Dr. H. A. Strey, Ph.D., M.A., a lecturer in literature at the University of Natal, and his wife, Karin, who was born in Natal and lost his sight at Meining in 1917. Dr. Strey, who has been associated with him in his work and who drives single-handed throughout, and William, a Bawanda native from Northern Transvaal who acted as servant, guide, interpreter and general Handy Andy and has seen, and not succumbed to, the wonders of London.

Catastrophe if War Came

For the most part the party contemplated their whereabouts, were anxious to know whether they were temporarily staying in hotel rooms or in flats. "I fear," Dr. Strey said, "that if we had to leave England it would not be very comfortable." He added, "I am afraid it is not a very restful night."

On another time in the first days of the trip, Dr. Strey vaguely offered to "sing" a fugue by J.S. Bach, but nothing more definite was done.

The couple lay through France and Spain to Gibraltar; thence across the Mediterranean to Tunis and Tripoli, and then to Algiers, Oran, and Marseilles, Algeria, across the Suez Canal, in the Indian Ocean, and through Japan, Korea, and the Far East, to Ceylon, the Malayan Peninsula, the Philippines, the Netherlands Indies, and Equatorial Africa, via Congo, Uganda, and Rhodesia.

Dr. Strey, who is still a student of the Royal College of Physicians, is writing his thesis under the guidance of Dr. L. B. Leyden, and he has a fellow student, Dr. Dunstan, a medical student, and a son, Peter, 10, with him.

After obtaining his degree, Dr. Strey plans to return to South Africa, and after obtaining his M.A. he will go to Rhodesia.

He conducted a three-year research among the Basotho tribesmen, and when he acquired William, our Bawanda, he made no secret of his intentions, however, by writing to his friends, "I have found a home in Africa."

William's brother, a doctor, has written him from London, enclosing a book on his findings, and he has decided to return to the Union overseas in order that he might be able to obtain employment. He wants to visit his countrymen, and his wife, Mrs. William, has remained with him ever since.

Medical Research Committee

MAIN PROBLEMS DEALT WITH BY GOVERNORS' CONFERENCE

Kenya and Uganda clocks will be put forward quarter of an hour and Tanganyika clocks retarded to the same extent on January 1. If a decision of the East African Governors' Conference is approved by the various Legislatures.

The Conference which met at Dar es Salaam last week has agreed to the creation of a Standing Medical Research Committee to deal with medical problems in the East African territories. It is hoped the Sudan will participate.

Proposals forwarded by the Secretary of State for the re-adjustment of salary scales applicable to new entrants to the professional and technical branches of Government service in East Africa received detailed consideration.

Problems connected with the co-operation of defence ministries were reviewed.

At a meeting of the Transport Policy Board which followed at the Governors' Conference the possibility of obtaining the services of an acknowledged expert on transport matters from the United Kingdom was considered.

Review of Salary Conditions

The following communiqué issued forward, it was found possible to include in the agenda for the creation of a Standing Medical Research Committee in which it is hoped that the Governors of the Sudan, Kenya, Uganda and the British Resident Commissioner of Zanzibar, met at Salama under the Chairmanship of the Governor of the British East African Territories (Sir Harold Meldrum), from June 2 until Monday.

At the opening of the Conference the following telegram from the Secretary of State was received:

In view of my recent appointment I desire to take a general review of pay and conditions of service within the East African Territories. The Conference now assembled will take every measure to expedite such investigations.

MEMPHIS, OREGON.—A reply was sent in the following terms:

Tariff Changes

In connection with a resolution passed by the Associated Chamber of Commerce, the Conference decided to postpone the consideration of adapting a common procedure for any future tariff changes that

might be considered desirable in the areas covered by the Conference. They agreed, however, that if any such changes were introduced, they should be simultaneous to executive orders issued by the legislatures. The Conference of Kenya had deferred from its original intention to adopt this procedure by the offer of a resolution that the matter would be raised on consideration of grounds in that Colony.

Coffee Conference

The Governors' decided with pleasure to extend what had been agreed upon for a meeting in September next between representatives of the East African countries of Kenya, Uganda and Tanganyika.

Safety of Aviators

Proposals for defining the responsibilities of Government in the event of an accident or emergency were discussed. It was agreed that the Governor of the territory in question should be responsible for the safety of all aircrafts.

It was also agreed that there was an urgent demand for more books of literature in Swahili and that an urgent task for the committee was to draw up a scheme for its use in the interests of the language.

The African Government's willingness to co-operate with the newly-formed Committee, various documents and aids were distributed.

The reports of these Technical Conferences were placed before the Government and the public, although the former did not suffice for a full statement of the numerous propositions then made.

Primate Appoints Committee

[Editorial]

Cries of "Shame" were heard at the meeting of the Lower House of the Convocation of Canterbury, when the Archdeacon of Dudley, the Very Rev. P. G. Smith, quoted an instance of a clergyman who divorced his wife on the ground of adultery and then, on remarriage, was given a better living.

Within the last five or six years, he added, "another clergyman became the third husband of a woman, whose divorced first husband was still alive."

The marriage was conducted with the full approval and blessing of the bishop of the diocese, and authorized by a prominent canon of the Church of England.

"A Really Horrible Thing"

The action before the House and the division of the House regarding whether or not clergy should not be admitted to sacraments except on such conditions as the Church might prescribe.

To this no amendment was moved to omit the words "except on such conditions as the Church might require."

Referring to a question, the President of the Diocesan Executive, the Very Rev. J. H. D. Clegg, said that if the amendment were carried it would then not be able to administer the Sacraments to those who had committed adultery.

The Dean of Hereford said that the canon did not cover the case of the divorced and remarried, but which one could arrive on that point, he said, was not clear.

He said that the Diocesan Executive regretted that he was prepared to sacrifice legal consistency rather than to allow the Church to do what it wanted. The role of the Church in the administration of the sacraments with regard to the moral standards of society.

CIVIL WAR OR JOINT ACTION AGAINST JAPAN?

Kemal in China appear to be shaping for a war, but whether it will be a civil war between North and South or will take the form of joint action against Japan is not yet clear.

Last reports suggest that considerable troop movements are taking place in both North and South or that an outbreak of fighting is imminent.

Anti-Japanese feeling is increasing and it is considered in some quarters that efforts are being made by the Southern authorities to force the National Government to combine with them against Japan.
