## SELECT COMMITTEE ON WAR PENSIONS

### Important Debate In Kenya Legislative Council

IT is a motion which most men with the general acceptance of the House in so far as the principal and main points are concerned, Col. Lord Francis Scott, member for Nairobi, moved on Friday, August 20, that war pension in Kenya Legisla-

tive Council be agreed to and that additional regulations be made for the payment of pension allowances and other allowances and methods of pension allo-

wances.

It is a motion which would

allow for the payment of

allowances to members which will not affect the members.

That all East African pensions must take some relation to the standard of living in East Africa, was a matter of discussion in the African legislative assembly, rather than in Royal Commissions, in view of the fact that Royal Commissions, and/or allowances require revisions, for the benefit of the designated Kenya members, (b) pensions for widows and dependents of widowers should be restricted to those granted to pensioners.

That was the question of the day.

# WHITE VALLEY ELECTORS ORGANISATION

## ANNUAL GENERAL MEETING

The next Annual General Meeting of the White Valley Electors Organisation will be held on Saturday, October 1, 1943.

### AGENDA:

- To elect the Chairman, Vice-Chairman, and Secretary.
- To receive the Organisational Committee's report.
- To approve the preliminary committee by the Organisational Committee.

- To consider and adopt a constitution.
- (b) Proposed by Mr. E. H. Hopper, recommended by Mr. Bell-Smith that members of a suitable capacity or standing be recommended to the members a suitable committee of candidates to represent the Constituency, and any persons otherwise so recommended shall be granted a seat and record as though other candidates in possession of the Organisation shall be in a position of re-nomination to him or them in his or their capacities.

The present agenda reads as follows:

### GENERAL ELECTIONS OR BY-ELECTIONS:

The Organisation having advised us to its duty of recommending a suitable Candidate or Candidates to its members, shall not take any further part in any way whatever in either a General Election or a By-Election.

4. To appoint a Chairman and a Vice-Chairman for the ensuing year.

(Note: The Rule re Management Committee reads as follows):

The Administration of the affairs of the Organisation shall be in the hands of a Management Committee. The Chairman and Vice-Chairman, two members from each affiliated Association, shall be elected at the Annual General Meeting each year. The Management Committee shall have the duty of the A.G.M. and the Secretary advised of the names of the Delegates before the Annual General Meeting.

Will affiliated Associations act accordingly.

5. Resolutions to be submitted at Meeting.

(1) That this Meeting resolve the suggestion that all persons serving on the Management Committee shall be paid a sum of £100 and urge Government to take the necessary legislation.

Proposed by Mr. E. H. Hopper, seconded by Capt. L. Sykes.

(2) That this Conference place itself only to support Candidates who are willing to serve as Chairmen, under a Chairman nominated by themselves.

7. Any resolution by an affiliated Association or by a member of the R.V.E.O. of which no notice has been given to the Secretary on or before 30th September.

(Note: A full text of these resolutions will be published later in the Press).

1. To make the European population stronger of the Rift Valley Constituency.

2. To work for an Equitable which shall make European and Kenyan interests compatible and to combat big business and the like who would seek to secure the same and can never in the future development of Kenya on the lines.

3. To work for a Policy which shall protect the interests of the Colony and descendants are protected and to press this upon our Native Members and act as an advisory body to him on all political questions.

4. To work to safeguard the Highlands as the permanent home of the Europeans and their descendants.

5. To work for full co-operation in Political, Social and Economic fields for the benefit of Agricultural, Commercial and Official Communities.

6. To foster and sustain interest in public affairs amongst the Electors of the Rift Valley Constituency and to work for the welfare of all persons living in the area as a whole.

7. To work to increase White Settlement in the Colony by every possible means.

8. To raise and administer funds necessary to effect the foregoing aims.

We feel that the above aims and objects will commend themselves to all Europeans in the Constituency, and we appeal to you for your active support, both financial and otherwise, every other way.

We propose to endeavor to collect from every Registered Voter in the Constituency an undemanding sum to subscribe the sum of £1 per year for five years, 1943 to 1947 inclusive, also to invite donations from every voter who has substantial interests in Kenya.

Our target is the sum of £1,000 per year for a period of five years, of which sum more than £100 per year will be spent on running this Organisation and the remainder will be a reserve to be used as and when critical.

Finally, it must be realised that the whole-hearted support of the European Community is required if we are to persevere through this period of trials. Your kind appeal with confidence for your support.
