£10,000,000 THEFTS OF DIAMONDS

Annual losses in
South Africa

ABOUT £10,000,000 worth of diamonds are stolen each year from South Africa, the 2nd largest producer of Interpol, the international police co-operation association, was told at its conference in Rome.

Mr. G. A. M. Steynberg, president of Interpol, said later that there was a world-wide diamond smuggling problem and drugs, at the conference, he devoted half-day to the new techniques used by criminals. He, he said, had 112 police agencies from 40 countries, and American and Latin American, European and Asian, to discuss the draft treaty to give Interpol the power to arrest and extradite犯人 the police and judicial process, as well as criminal justice.

53 crooks arrested

He said 15 Interpol members had gone into action on 2,600 cases of diamond smuggling. 53 crooks had been identified and 112 persons interposed have been made guilty of 23 different international crimes.



COMPENSATION TO VICTIMS OF EMERGENCY £250,000 paid out by Government

AFRICAN MEMBER CALLS FOR ANOTHER 'ANVIL'

THE possibility of rehabilitation loans and free grants to farmers who had suffered from Mau Mau was mentioned by the Secretary to the Treasury, Mr. E. J. Petrie, when the debate on the Emergency was continued yesterday in Kenya Legislative Council. It was decided that £250,000 had been paid by the Government in compensation to victims of Emergency.

The debate was on a motion proposed by W. E. Cresswell (Mau), while supported by the Government. It has been during the past year by the security forces against the destruction of the Mau Mau gang, is considered that Government's responsibility in this regard is clear. The State of Emergency may be brought to an end by a successful and conclusive decision and is determined to make such efforts.

Mr. J. B. Blunt, Minister without Portfolio, wound up the debate last night. The motion was carried but was not passed to a division. It was decided that it was necessary to have another "Operation Anvil" in Nairobi, where he claimed, Mau Mau was again very active.

A suggestion was made by an Asian Member, Mr. Chanan Singh, that the ranks of the Royal Engineers should be thrown open to all races. If the current situation did not permit this, then the services were reasonable and acceptable.

Seconding the motion Mr. J. S. G. (Kenya) Arora urged that security should be given to dependents and relatives of those who gave the greatest service to the country.

The committee dealing with claims for compensation had decided that the amount paid was £250,000 and that more could be more in future.

The Government should bring farmers back to production, and loans did not meet the case, it was decided that the Government would finally make arrangements.


