3,000/- FINE IN SEDIATION CASE

A SENTENCE of 16 months imprisonment passed on Joseph William Riwakwala, editor of the "Uganda People," and publishing a seditious document, has been reduced to 3,000/- on appeal to the High Court in Kampala.

Mr Justice A. J. Amey, who only decided to decide on the sentence after he had been raised in holding that the trial judge had been unfair in holding that the accused was guilty of sedition.

It could be fairly said, without going into details, that the only question to decide was whether or not the accused was guilty of sedition.
