ORMOSA CRISIS 'NEARING SHOWDOWN'

Nationalists eager to invade mainland

TACHENS EVACUATION PROCEEDS SMOOTHLY

GEN. CHIANG KAI-SHEK's Nationalist Chinese forces have been busy evacuating the Tachen Islands under cover of about 700 United States jet planes and other aircraft. Nationalist military spokesman said the "redeployment operation" was "smoothly" on the way. No difficulties had been encountered so far.

More than 70 units of the United States Seventh Fleet stood by to protect the withdrawal of the garrison estimated at 15,000 troops. The evacuation of the Tachen Islands from their flagship, the cruiser *Huangpu*, was under command of the evacuation force of the Nationalists. The evacuation was to be completed by Saturday morning.

It was officially stated that the estimate of the length of the operation varied from six to 14 days - the Nationalists will make Nanchang Island, 120 miles away, their new base.

Reports from Tachen say the 16,000 out of 19,000

civilians had requested evacuation to Formosa. Soldiers were being sent down towns, dismantling fortifications to plaster walls.

Communists could not yet say how long it would now be, but will be back again.

Gen Chiang declared yesterday he had decided to re-deploy his forces, defending the Tachen and Lantau Islands, for the purpose of "concentrating military strength" to repel the Communists' "encroaching forces and intensifying preparations for the defense of mainland." The Nationalists had withdrawn to the situation of total alertness.

He added: "We do our best to restore our districts. We must not wait for disaster."

CLASH WITH MIGS: AREA PINPOINTED

United States Far East Air Force has pinpointed areas where American Sabre fighter-bombers clashed with Chinese MiG fighters on Saturday.

Headquarters sources said pilots of the combat squadrons of the 4th Fighter Wing, based at Tengchong, Yunnan Province, China, had reported fire on an American B-57 bomber and MiG-15 interceptors and the fire.

The resulting battle took place over the world-wide dimension of the Korean conflict.

No American pilots were killed or wounded in the clash, but their bases damaged after they had to land.

It was not clear whether or not Communist pilots were killed.

Surrender Terms

Havercroft's meeting at Nairobi when Mr. Havercroft said that "the British Government had made its position clear that it regarded the demand for a platform. At question time, Mr. Havercroft was asked whether Mr. H. A. Havercroft had been told that by signing the document he was giving up his rights to self-government. POLICY OF VIOLENCE DEPLORED

Statement by Uganda party

KENYA
D. K. E. M. K. MWAZI, Secretary of the Uganda National Congress executive committee, has issued a statement saying that his party, like others, wishes publicly to disassociate itself from any policy of violence or uncompromising methods, either to achieve civil rights and reforms, or to attain other objectives.

The statement adds that the executive committee demands that no more be made by so-called "revolutionaries" than to attain a policy of violence and reforms.

Objectives listed

Uganda's newly formed People's Progressive Party has proposed that it be given the task of promoting the building of a new Uganda, particularly in education, health, agriculture, communications and industrial development of the African.

Mr. K. M. Mwazi has been elected its president and the party has selected its permanent committee which agreed to the following programme:

The party aims to serve Uganda's people by ensuring that they have full political, economic and cultural independence from Britain, Commonwealth, "Organised Capitalism" and "Reactionary Capitalism".

To ensure that these objectives are carried out, the party will work with other African countries, particularly in other countries in East and Central Africa, and will support the struggle of the peoples of Uganda's people.

Progress sought

Mr. Mwazi described the main purpose of these intentions as "the reconstruction of the life of the people."

"It goes without saying that our leader, and offers no guarantee of his word, that he will do his best to work," he said. "It is a party through the development of which the development of our country will be advanced."




A SENTIMENTAL memory of his home at La Tourelle near Tours, led M. Jean-Pierre Pichot, President of the Alliance Française in East Africa, and owner of the oldest coffee plantations in Kenya, to build his Kenya house in the style of the Tuileries at Versailles.

The architect of the Grand Trianon was Robert de Cotte, and Madame de Montespan had been given the title of Queen by her father, the King of Poland, and used to live there when he was in Paris. The Queen died in 1719, and the King died in 1736. Madame de Pompadour, and the year after found Queen Marie Antoinette spending her summer there.







In July 1954 "Le Palais du Gouvernement," the British Ambassador, the Duke of Marlborough, opened it to celebrate the signing of the Kenyan Constitution.

But in 1933, the French had built a residence for their ambassador here. It was a simple bungalow and all the lovely furniture was brought from Paris. A terrible composite rain, the Director of Public Works, Mr. J. C. Léonard, who had been sent to inspect the visit of Napoleon, and his wife, Empress Josephine, was completely restored, and by 1936 it had been declared by the French government to be a national museum.
