THE flood waters after the
heavy rains last week over the
over the River Nyoro at Archer's
Post, in the Central Province, have
caused considerable damage. On
March 21st at one time the water
was 12 ft. above the level of the

continued to rise. Debris of timber
was brought down by the swollen river.

The bridge across the river
was washed away and the bridge
is now being repaired. The
delay of nearly three weeks in
the re-opening of the river
had anticipated, communications
with the outside world were
broken. A team of porters and

structure over which people
walked and, by means of a rope
strung over the stretch of
water, people crossed.







Ruling on 'month's notice'

GRANDCOURT STAFF BRITANNIA

PLEA, you can understand, "one month's notice" is a month's notice usually and entitled to a month's notice in law of notice after severance of a tenancy. This was the effect of a ruling given by the Court of Appeal in London in the Supreme Court at November 1950.

Mr. P. H. Patel, formerly managing director of the firm of works by LEBER (SEY) LTD., Chelmsford, Essex, Mr. Justice Rogers, Mr. Justice Lawther and J. M. Davies his recorder, presided.

It was alleged that on April 15, 1950, Mr. Patel was dismissed without notice by defendants.

He claimed he had been given notice of his dismissal on April 1 and 2, 1950, so one month's notice was due, April 20, 1950, at the value of £100 per month. Defendants denied this, contending that he had been dismissed on April 15, 1950, and that the notice period ended on April 15, 1950.

Mr. Justice Windham accepted the plaintiff's case.

Defendants admitted that they dismissed Mr. Patel without notice on April 15, 1950, but claimed that he should have been paid his salary up to April 1 and 2, 1950, so one month's notice was due, April 15, 1950.

Mr. Justice Jameson, in his judgment, held that while similar cotton experiments had been made in India, the United States and Britain, there was no record of such experiments in South Africa.
