Unions want varsity boss appointed

and staff at the Lecturers University of Nairobi yesterday stepped up pressure on Education Cabinet Jacob Kaimenyi to appoint a substantive Deputy Vice-Chancellor.

The University Academic Staff Union and the Kenya Universities Staff Union said the delay in the appointment of the deputy had made it hard for them to start talks on a collective bargaining agreement and staff welfare issues.

The deputy is in charge of administration and finance at the university.

"There are no clear reasons why Prof Kaimenyi has not appointed a deputy vice-chancellor. He was given the list in February and we wonder why he is sitting on it untill now," said the university's union chairman Samwel Nyandemo.

Top candidates

Dr Nyandemo observed that the position is key and it should therefore not be held in acting capacity.

The position became vacant following the elevation of Prof Peter Mbithi to Vice-Chancellor in January this year.

Currently, Prof Henry Mutoro is holding the position in an acting capacity.

In February, the university council chaired by Dr Idle Farah carried out interviews and submitted the names of successful candidates to Prof Kaimenyi for appointment.

They included Prof Bernard Njoroge who scored 78.89 percent, Prof Enos Njeru's 71.33 percent and Prof Isaac Kibwage who scored 70.33.
Prof Bernard Adeda scored

60.67 per cent.
